DETAILED SPECIFICATIONS

1. Scope of Work

iThemba LABS invites bidders to submit proposals for a comprehensive data protection solution for transporting, storing, managing and retrieving our backup media from a secure, offsite facility. The service should be rendered for a three-year period and includes media tape storage, retrieval and weekly collection and returns. A Service Level Agreement (SLA) must be documented and entered into between NRF\iThemba LABS Cape Town and the vendor providing offsite storage.

2. Specifications

2.1. Storage of Tapes:

- 2.1.1. Vendor should have proper environment controls, temperature, humidity and fire protection at the storage location adhering to the requirements stipulated by the SABS and SA Fire Association.
- 2.1.2. Vendor to provide relevant tracking labels for containers to be transferred from our offices to the off-site storage location.
- 2.1.3. The containers must meet the following requirements:
 - Securely locked, foam lined, dust and waterproof.
 - Containers locked and sealed, ensuring security and confidentiality of contents.
 - Containers should be assigned a unique number reference.
 - Containers should include inserts that hold the tapes firm in transit.
- 2.1.4. Provision of containers, seals and locks.
- 2.1.5. Provision of a container on request.

2.2 Collection and Delivery

- 2.2.1 Collect and deliver once a week a rotation of LTO tapes during office hours. Monday to Friday 8:00 – 16:00 at a designated time.
- 2.2.2 Provision should be made for secure container transport, storage and rotation for each weekly, monthly and yearly schedule.
- 2.2.3 Vehicles Should be equipped with the necessary safety and security measures to secure containers during transit.
- 2.2.4 To return on next Collection day the LTO backup tapes that were collected on previous weeks as per rotation schedule.
- 2.2.5 Tapes to be transported using secure sealable containers.

2.2.6 Ability to provide and deliver tapes within a 4-hour period in case of emergency.

2.2.7 Safe custody of containers.

2.3 Containers

2.3.1 Ability to track container.

2.3.2 Storage for a duration of 36 months.

2.3.3 Container should be able to hold 8 LTO tapes.

2.3.4 Containers are only released to pre-designated and authorized personnel.

2.3.5 Three Yearly canisters to keep for the duration of the SLA.

2.3.6 Cost for the permanent removal of tapes at the end of SLA.

2.3.7 Vendor should be able to provide a full audit trail of the containers they pick up and deliver.
