To keep abreast with the 4IR address and improve the limitations of water resources monitoring, Umgeni Water has started implementing automated water resource monitoring instruments. UMgeni-uThukela Water (UJW) currently has installed automated water resource monitoring equipment's at Amanzimnyama, Olifantskop, Crystal Springs, Nungwane, Mhlabatshane, Imvutshane Dams amongst others. uMgeni-uThukela Water requires a supplier to install similar equipment's at Coastal Areas. The sites name and co-ordinates for installation site are as following
