1. INTRODUCTION.

Gateway Airport Authority Limited (GAAL) seeks to appoint a suitably qualified, reputable, and experienced service provider for the servicing, repairs and maintenance of high pressure breathing air compressor at the rescue and firefighting section, Polokwane international Airport.

Servicing, repairs and maintenance of high-pressure breathing air compressor is a requirement in terms of South African Civil Aviation Authority for safety and security reasons.

2. SCOPE OF WORK
