TERMS OF REFERENCE – APPOINTMENT OF A FUTURIST TO ASSIST THE PROJECT MANAGER AND SANPARKS TO FACILITATE THE DEVELOPMENT OF A VISION 2040

INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our **mandate** is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our **mission** is to develop, expand, manage, and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Chief Operating Officer's (COO) Division is led by the Chief Operating Officer who is appointed in accordance with and has the duties as prescribed by the National Environmental Management: Protected Areas Act, 57 of 2003 and the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999). The COO division was established in order to support SANParks with the governance, strategy and business efficiency work especially in light of the non-application of the Companies Act and its various prescribed officers. This was in light of the recognition that Schedule 3(a) entities are, in terms of corporate governance, business efficiency, etc. more like government Departments (in terms of the prescripts applicable) than a company or a State Owned Enterprise (SOE).

CONTEXT OF THIS PROCUREMENT

South African National Parks (SANParks) seeks to contract a consultant (Futurist) to assist them to strategically conceptualise emerging themes and scenario for the long-term sustainability of the SANParks into the future (2024) through the development of the Vision 2040 Strategy. The position is based in the Groenkloof National Park, Pretoria but consultation sessions/ workshops may be held outside Gauteng.

The purpose of this Request for Bid is to contract with a suitable qualified Futurist with the requisite capacity to execute this project within the desired quality, scope, time frame and cost for SANParks.

CONTRACT PERIOD

The duration of this contract will be for a period nine (09) months with an estimated four (04) days a week.

SPECIFICATIONS/SCOPE OF WORK

Vision 2040 Project

The Board of SANParks has resolved to lead a process of development of a long-term vision for SANParks. This specifically relates to ensuring that SANParks carries out its mandate and creates meaningful opportunities for sustainable funding of that mandate through diverse tourism offerings. This project is called Vision 2040 to denote its long-

term nature rather than the normal five-year planning horizon usually adopted for strategies. In this regard the board has established a Project Steering Committee (PSC) to provide strategic direction and guidance in the development of Vision 2040 and its associated Strategy for implementation.

In addition to the PSC, a Project Manager (PM) and Project Administrator (PA) have been appointed for the overall coordination of the Phased Vision 2040 project, including:

Phase 1: Vision development and confirmation and the strategy to develop on the vision over 3 Medium Term Strategic Framework (MTSF) periods;

Phase 2: Designing the organisation that can deliver the mandate and Vision 2040 and the change management process necessary for implementation.

SANParks seeks to contract a consultant / consultancy more specifically a Futurist, to assist them to develop a Vision 2040 strategy through a series of consultative processes.

The Futurist will be expected to facilitate consultation with the wide range of stakeholders (including internal stakeholders) identified to develop (co-create) the scenario-based Vision 2040 and to obtain buy-in from stakeholders into the vision and process.

The key outputs will be:

- The Futurist is to assist Project Manager to develop an approach for all consultation sessions that will stimulate futuristic thinking.

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

Performance or supervision of on-site assembly and/or commissioning of the supplied goods; 13.1.2. Furnishing of tools required for assembly and/or maintenance of the supplied goods; 13.1.3. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights, which the purchaser may have against the supplier under the contract.

Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
GCC1 8	18. Contract amendment
	18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
GCC1 9	19. Assignment

	21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract. 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract. 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority. 21.4. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated. 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed.
