1.	The Eastern Cape Department of Rural Development and Agrarian Reform Invites Professional Service Providers for the Provision of aquatic study and licensing on a borehole. Six (6) Month contract. The team leader shall be a competent Registered Professional, registered with South African Counsel for Natural Scientific Professionals (SACNASP). The works shall be done in Nchodu AA, Matatiele LM, Alfred Nzo District. The works shall include the following: Professional Consultancy led by a registered Environmental Agent that shall perform the duties of project management on behalf of the Department and shall lead a team of professionals selected by him/her for the aquatic study on the 500m buffer area from the borehole, licensing of an existing borehole with the department of Water and Sanitation, and compilation of report. The scope of work for this project entails the provision of professional services for aquatic study and mitigation measures from the impact of proposed construction. The main tasks are as listed below: • Conducting an aquatic study on a minimum of 500m radius from the borehole. • Identifying impact caused/to be caused by the existing borehole on the wetland, springs and streams/lakes in the 500m radius. • Providing mitigation measures on the impacts identified. • Application of a license with Water and Sanitation for the existing borehole. • Preparation of close-out report. 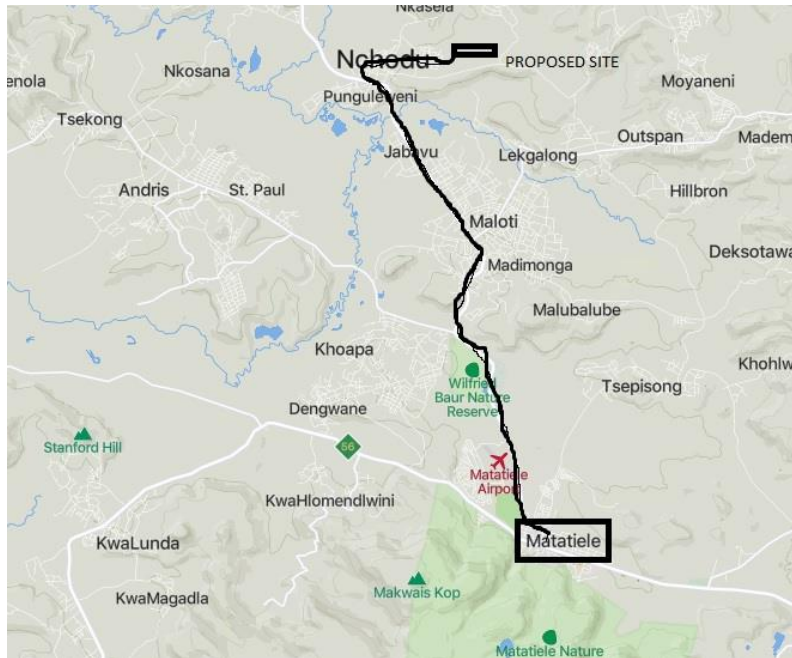

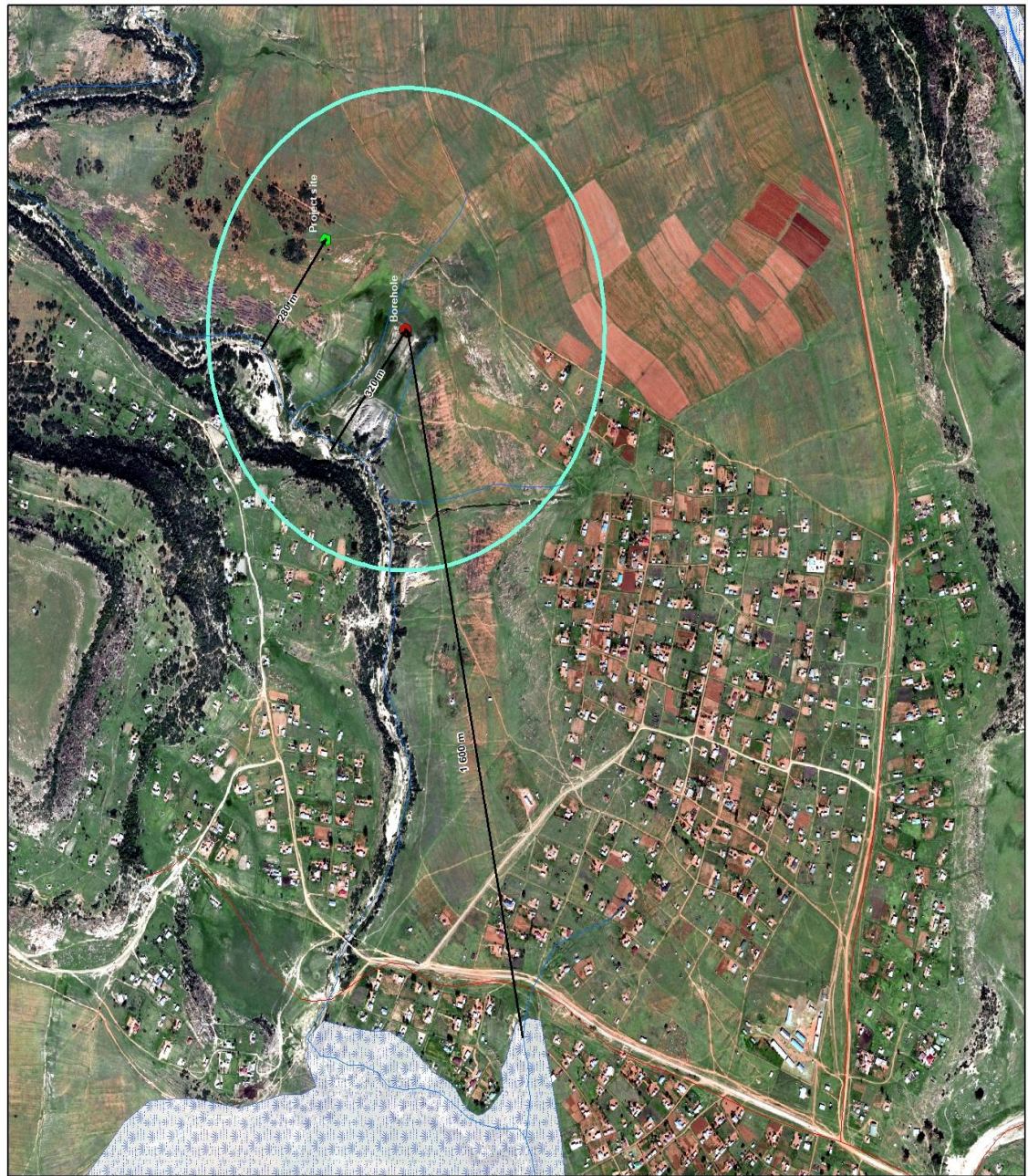

BAKHESI GROUP PIGGERY PROJECT

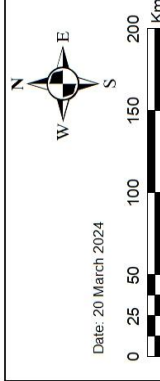

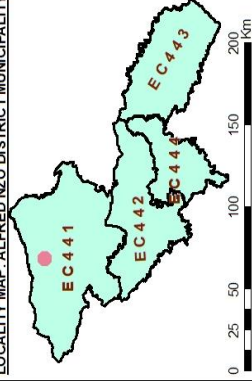
