Tenders shall be placed in sealed envelopes, endorsed with the correct **project name and Bid number** for the project, and be placed in the Tender Box at the Municipal Offices, 5 Keet Street, Kareedouw, 6400, not later than **12h00 on Friday, the 27th of August 2021**, at which time the tenders will be opened in public. Tenders are to be submitted on the tender documentation provided by the Municipality. Late, electronic or faxed tenders will not be accepted. A tender must remain valid for a period of 90 days from the closing date for the submission of tenders.

Bids will be evaluated and adjudicated according to the following criteria:

- 80/20 preference points system will apply in terms of the Preferential Procurement Regulations, 2017 (B-BBEE Status Level of Contribution - an original or certified copy of the certificate is required)
- The guidelines for locally produced or manufactured goods with a stipulated minimum threshold where applicable will be applied.

NB: No tenders will be considered from persons in the service of the state

Telegraphic, telexed, faxed or emailed tenders will not be considered. Tenders that are not submitted in properly sealed and marked envelopes and/or deposited in the tender box as prescribed in this notice on the date and time indicated will **NOT** be opened or considered.
