

REQUEST FOR THIRTY-SIX MONTHS OF PORTABLE TWO-WAY AIR BAND TRANSCEIVER RADIO'S FOR SUPPLY AS AND WHEN REQUIRED, SERVICING, REPAIRS, ROUTINE MAINTENANCE AND SUBSCRIPTION OF AIRTIME-iTalk radios NON-NFC PORTABLE TO BE PROVIDED AT POLOKWANE INTERNATIONAL AIRPORT.

1. PURPOSE.

Gateway Airport Authority Limited (GAAL) seek to appoint a suitable qualified, reputable and experienced service provider of Portable two-way Air Band Transceiver Radios for Supply as and when, Supply of portable iTalk or similar compatible radios as and when required, Servicing, Repairs, routine Maintenance and monthly subscription of airtime iTalk Non-NFC Portable x20 radios that can cover the minimum of 10km radius to be provided at Polokwane International Airport.

The supplier is to supply a radio Apron operations frequency channel approved by ICASA, registered and cover 10km radius and this must be compatible with current ATC radio and portable radios.

2. BACKGROUND

Gateway Airport Authority Limited (GAAL) seeks to appoint the services of reputable service provider for provision of Portable two-way Air Band Transceiver Radio's for the airport operation department for several important reasons:

- Instant Communication – They provide immediate, real -time voice communication between personnel, which is critical during emergencies when every second's counts

- Reliability – Unlike cell phones, two-way radios function reliably in areas where cellular coverage may be poor or overwhelmed, such as inside hangars, underground tunnels, or remote parts of the airport
- Durability – Radios are built to withstand harsh environments including exposure to water, dust, and physical impacts, which is common in emergency response situations
- Group Communication – They allow simultaneous communication with multiple team members or units, enabling coordination and sharing of critical information quickly and efficiently
- Battery Life – Radios typically have long battery life and hot-swappable batteries, ensuring continuous operation during extended incidents
- Prioritized Channels – Radios can have priority channels for urgent messages, helping to manage communication effectively during high-pressure scenarios
- Interoperability – they can be integrated with other emergency services communication systems, facilitating coordination among different agencies during large-scale emergencies
- Hands-Free Operation – Many radios support hands-free or push-to-talk functions, allowing firefighters to communicate without using their hands, which is crucial while managing equipment or performing rescues
- NB: In summary, portable two-way radios enhance coordination, improve safety, and increase the efficiency and effectiveness of airport fire and rescue operations

SCOPE OF WORK

GAAL seeks to appoint the services of a reputable service provider who has traceable track record on portable two-way radios

Specification

Provided Servicing, repair, routine maintenance and monthly subscription of airtime- iTalk Non-NFC Portable two-way air band transceiver x 20 radios.

Supply an operations radio frequency channel compatible with current ATC radios and approved by ICASA and must cover 10km radius.

3. EVALUATION CRITERIA

All quotations will be evaluated in terms of administrative requirements, and preference point system.
