The following corrections will replace the above-mentioned clause-
Groundwater and surface water quality monitoring

- the sampling, analysis, and monitoring of relevant chemical variables must occur on a **quarterly and biannual basis** in line with Operational License annexures ii and iii.

The amendment will ensure alignment to the tender document, regulatory requirements and environmental best practices.
