1. BACKGROUND

Emergency medical supplies are an essential life-saving therapy which is critical in the provision of emergency medical treatment. The Emergency Services to ensure consistent and steady supply of emergency medical supplies to ensure uninterrupted service delivery to the community of CoT. All emergency medical supplies are replaced against a Patient Treatment Form and are only issued to staff according to their HPCSA scope of practice.

2. PROJECT SCOPE

It is the intent of the City of Tshwane Emergency Services Department that these specifications cover the supply, delivery and off-loading of emergency medical supplies.

The bidder shall be considered only from companies which have a reputation for quality products in the field of supply, delivery and off-loading of emergency medical supplies not exceeding a period of twelve (12) months.

The bidder shall submit proof of license with the South African Health Product Regulatory Authority (SAHPRA) to supply medical products or will result in the bidder being disqualified.

Items must be priced individually at a cost per unit price. However, for evaluation purposes, the quotation will be awarded to the highest scoring bidder at the total price per section. Bidders will be disqualified if no unit price is provided per item within a section.

 - ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
 - iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
