contribution of 30.03% of the project's contract value towards subcontracting. The Contractor shall also be required to provide
developmental support to Targeted Enterprises.

The requirements of the CIDB B.U.I.L.D. Programme with respect to the Standard for Skills Development is set at a maximum
development support of 0.25% of the project's contract value.

Tenderers shall be required to demonstrate that they will have in their employ during the contract period the necessary personnel
satisfying the requirements of the Scope of Work for labour-enhanced competencies for management and supervisory personnel. are
eligible to submit tenders.
