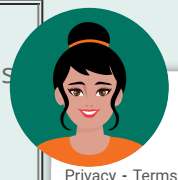

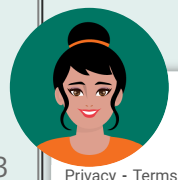

SECTION 8 BETWEEN SECRETARIS (KM 80.00) AND KIMBERLEY (KM 99.50). This project is in the Province of the Northern Cape and is located in the Frances Baard District Municipality and in the Sol Plaatje Local Municipal area. The approximate contract duration is 10 months which includes 2 (two) months for the Mobilisation Period. CIDB Regulation 25(1B) will not be applicable to this contract. Only tenderers with a B-BBEE contributor status level of 1, 2, 3 or 4 and who are registered on the National Treasury Central Supplier Database and meet the minimum threshold designated for local production and content as stated in the Tender Data C.2.1.1, are eligible to tender. It is estimated that tenderers should have a CIDB contractor grading designation of seven (7) CE or higher, however tenderers attention is drawn to clause C.2.1.1 of the Tender Data when submitting their tender. Tenders from tenderers registered as potentially emerging enterprises but with a CIDB contractor grading designation lower than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25(7A) of the Construction Industry Development Regulations, will not be accepted. If the tenderer is a QSE, it is a requirement of this project that the successful tenderer subcontract a minimum of thirty percent (30%) of the work by the end of the contract to Targeted Enterprise(s) as defined in the Contract Data. If the tenderer is not a QSE and has less than 51% Black ownership then it is a requirement of this project that the successful tenderer subcontract a minimum of fifty percent (50%) of the work by the end of the contract, to Targeted Enterprise(s) as defined in the Contract Data. If the tenderer is not a QSE and has equal or more than 51% Black ownership then it is a requirement of this project that the successful tenderer subcontract a minimum of forty percent (40%) of the work by the end of the contract, to Targeted Enterprise(s) as defined in the Contract Data. If the tenderer is not a QSE and has equal or more than 51% Black women or Black youth ownership then it is a requirement of this project that the successful tenderer subcontract a minimum of thirty percent (30%) of the work by the end of the contract, to Targeted Enterprise(s) as defined in the Contract Data. **TENDER DOCUMENTS** Tender documents are available at no cost in electronic format downloaded from the SANRAL's website by the following link: <https://www.nra.co.za/service-provider-zone/tenders/open-tenders/> from Friday 01 October 2021.
