SECTION 1

1 INTRODUCTION

THE RENAISSANCE THEATRE, trading as THE SOUTH AFRICAN STATE THEATRE, a cultural institution in terms of the provisions of section 3(1) of the Cultural Institutions Act, 1998, also a Schedule 3A Public entity under the Public Finance Management Act, 1999 (the "SAST"), is a statutory agency tasked with the development, promotion and mainstreaming of Arts, Culture and Heritage programmes to contribute to the economic development of the sector and to foster social cohesion in Tshwane, greater Gauteng and all the citizens of our Society.

1.1 OBJECTIVE

The SAST hereby seeks to appoint a suitably qualified service provider to remove the existing parking system, supply, deliver, install and commission a new parking system at the South African State Theatre. The service provider should render the maintenance of the system for a three year period, of which the warranty will cover one year of the three years. The ownership of the system and hardware, including licenses thereof, shall remain SAST's property after the installation and after the three year maintenance contract has lapsed. The service provider must supply and install all the hardware/end-to-end solutions within the system.

1.2 SCOPE

To install and maintain a pay on foot system.

Detailed specification is as follows:

❖ Pay on Foot System

Workmanship

6 x pay stations.

The pay stations should be digital media and allow marketing and advertising for SAST

Pay stations to be able to cater for the following:

- Uninterrupted power
- System should allow ERP system integration ,electronic invoicing, statement generation, import and export into to pastel evolution version 7.2.0.4.000
- Debit cards
- Credit cards
- Flat rate fee
- All notes and coins, (exclude 50 cents 20cents and 10 cents)

- Query reports for all parking system related matters e.g., tickets investigations, receipts, monthly parkers query, double tagging, etc.
- To be able to connect from home.
- Daily reports
- Flat rates report
- Monthly reports
- Quarterly reports
- Bulk Ticket buying for Shows, events/functions. The system should be able to program the bulk ticket start and end date for Shows, events and functions.
- Be able to load coupons on your card.
- The parking system should have a tap banking option.
- The parking system should be able to create parking pass tickets for functions and shows

1 x Office Cashier / Till station

Office cashier to be able to cater for the following.

- Short- and long-term parking tickets for functions and performances.
- Lost tickets.
- Accounts for daily parkers
- Flat rate time (like pay stations)
- Validity of the ticket

A ticket should be valid for 15minutes to allow free drop off time)

Evening flat rate from 17h00 to 00h00

Saturday and Sunday flat rate the whole day)

The system to be flexible should there be changes.

Exits and Entrances.

- 6 Touchless ticket dispensers/card reader at entrances including booms and boom holders
- 6 tickets Dispensers/card reader at exists including boom and boom holders
- 1 non retracting ticket acceptor(dual lane) exist
- 3 parking levels
- Spikes should be surface mount including robots at the entrances and exists

Installation

- Bidders should provide training for 4 staff members after installation of the parking system.
- Bidders should provide a minimum of one year (12 months) warrantee and 2 years Maintenance

and support contract after installing the parking system.

1.3 Pricing Schedule

The following requirements must be included in the proposals:

- Pay on foot system
- 13 Entrances and exits.
- Boom gates, card reader/ticket dispenser x number of booms (12)
- 8 Surface mount spikes boom, spikes must comply with the road traffic act 93 Of 1996
- 6 pay points
- 2 Year Maintenance and support
- 6 touchless access control for cars
- Ticket management system software.
- Bidders can also attach a detailed quotation based on the above items.

NB: Bidders must attach a detailed price quotation in respect of the above and any other costs associated with the supply, delivery, installation and commissioning of the Parking system. This should also include de-commissioning of the existing old system.

SECTION 2

1. INSTRUCTIONS TO BIDDERS

2.1 General

Bidders must familiarize themselves with and comply with the mandatory requirements and ensure their availability for site visits and presentations, as required, on the appropriate dates.

2.2 Bidder Information

The required information on the bidder must be completed as stipulated in **paragraph 4 below. Failure to do so may result in disqualification.**

The successful bidder shall demonstrate to SAST that adequate pre-employment screening, including security screening was performed on the employees/sub-contractors (staff).

2.2.1 The pre-employment screening shall as a minimum be:

2.2.1.1 Authenticate that staff are who they claim to be;

2.2.1.2 Confirm that staff have a right to work in the RSA;

2.2.1.3 Obtain written declaration from staff of any criminal record; and

2.2.1.4 Confirm that staff possesses the relevant qualifications to undertake the duties effectively and safely.

2.2.2 The successful bidder shall deploy competent staff, supervision and labour who are:

2.2.2.1 Appropriately experienced and trained for the work they are to undertake.

2.2.3 SAST and its representatives may seek formal assurance to this effect (including a formal (audit) at any time during the contract period.

2.3 Consortium

2.3.1 Bidders forming part of a Consortium must submit with their bid a copy of their Consortium agreement in a separate attachment. This must clearly indicate:

2.3.1.1 The form of agreement;

2.3.1.2 The respective roles and responsibilities of the members;

2.3.1.3 The identity of the lead company which will have overall responsibility;

2.3.1.4 The name and address of the officer acting as a single point of contact for

2.3.1.5 Communications between SAST and the tenderers. He shall be fully empowered to act on behalf of all members; and

2.3.1.6 The member's agreement to be jointly and severally liable to SAST for the performance of the contract.

2.4 Sub-contracting

- 2.4.1 Bidders must detail any work to be sub-contracted, the proposed sub-contractor(s) to be used,
- 2.4.2 SAST reserves the right to reject the use of any of the bidder's proposed subcontractors and any subcontractor proposed during the contract term.
- 2.4.3 Bidders are advised that SAST will not respond any direct approach from potential sub-contractors for details in respect of any particular item in this bid.

2.5 SAST Bidding rights

- 2.5.1 SAST reserves the right to:
 - 2.5.1.1 extend the closing date;
 - 2.5.1.2 verify any information contained in a proposal;
 - 2.5.1.3 Request documentary proof regarding any bid issue;
 - 2.5.1.4 Give preference to locally manufactured goods or locally sourced services;
 - 2.5.1.5 Issue follow-up or supplementary questions during the response period or after receipt of tenders;
 - 2.5.1.6 Make known to all bidders any questions submitted by a bidder including commercial and technical clarifications, together with answers given to any individual bidder, if it is considered to be relevant to the tender; and
 - 2.5.1.7 Cancel or withdraw this request for tender as a whole or in part.

2.5.2 Evaluating Authorities' (BEC) of the evaluation process SAST may require bidders to arrange and/or participate in one or more of the following:

- 2.5.2.1 Interviews with, or written references from nominated references;
- 2.5.2.2 Reference site visits to the location(s) of nominated reference;
- 2.5.2.3 Interviews with bidder personnel who would be involved in the contract execution (day-to-day operations of the site);
- 2.5.3 Negotiations with the bidders.
- 2.5.4 Appoint one bidder or more than one bidder where necessary.

2.6 Bidding process

2.6.1 Bidders must familiarize themselves with and comply with the procurement time table and ensure their availability for the site visit and presentations, as required, on the appropriate dates.

- 2.6.2 Bidders are required to:
 - 2.6.2.1 respond in the English language;

2.6.2.2 A cover letter on the bidders company letterhead with clear reference to the bid of interest should accompany both the technical and pricing proposals;

2.6.2.3 All copies of the tender response must be signed on each page.;

2.6.2.4 Ensure that all document attachments are clearly marked and bound in a clear, logical and well-marked format with a table on context ensuring ease of finding individual documents or sections; and

2.6.2.5 The original document must be signed in black ink by an authorized person, agent or representative and each and every page of the bidding documents shall contain the initials of the same signatory.

2.6.3 All costing and information must be typed and signed by the bidder, no hand written costing/pricing will be accepted.

2.7 Bid submission requirements

2.7.1 Bidders must submit their responses and all supporting documents in properly labelled and sealed envelopes

Bidders are required to submit one (1) pack of original proposals, marked "ORIGINAL" in a separate envelope and two (2) packs of copies, marked "COPY" in a second envelope. Financial or pricing details must ONLY be included in the pack marked "ORIGINAL".

Bids must be submitted in sealed envelopes clearly labelled to reflect the **bid number** and **description, submission date and closing time**.

Bids must be bound, indexed and set out in a tabulated format. Unbound or loose papers will be rejected. **Unbound document submission will be disqualified.**

Bidder must also submit an ***ELECTRONIC SUBMISSION of their bid document (USB)***

NB: Failure to submit 1 original pack with financial/pricing details and 2 packs of copies (without financial/pricing details), will result in your bid being disqualified.

2.8 EVALUATION PROCESS

Evaluation criteria

Bids that meet compliance requirements will be evaluated in two stages, which includes functionality (Stage 1) and Pricing and B-BBEE Status (Stage 2).

Compliance with minimum requirements

All bids duly lodged will be examined to determine compliance with bidding requirements and conditions (completion and attachment of compulsory documents).

Elimination of proposals on grounds of functionality

Bids that score less than 80 points for functionality will be eliminated from further participation in the Bid Evaluation process (Stage 2).
