- 3.1 Please sign documents [sign, stamp and date the bottom of each page] before submitting them. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 3.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 3.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 3.4 **Bidder responses must include a soft copy of the submission in the form of a USB Flash Drive (stick).**

- 3.5 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 12 below (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

4 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Foskop through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Foskop.

- Respondents are to note that for the purpose of Evaluation, a JV will be evaluated based on one consolidated B-BBEE score card (a consolidated B-BBEE Status Level verification certificate) Preference points will be awarded to a bidder for attaining the specific goals requirements in accordance with the table indicated in Table 3.2 of the specific goals Claim Form.

5 COMMUNICATION

- 5.1 For specific queries relating to this RFP, an RFP Clarification Request Form should be submitted onto the system and to [Clayton Losper] before **12:00 pm, 2 August 2024**, substantially in the form set out in Section 8 hereto. In the interest of fairness and transparency, Foskop's response to such a query will be published on the e-tender portal and Foskop website.
- 5.2 After the closing date of the RFP, a Respondent may only communicate with the DBAC Secretariat **Mpho Thiphe** at telephone number 011 347 0607, mphot@foskor.co.za on any matter relating to its RFP Proposal.
- 5.3 Respondents are to note that changes to its submission will not be considered after the closing date.
- 5.4 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Foskop in respect of this RFP between the closing date and the date of the award of the business.
- 5.5 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

6 CONFIDENTIALITY

All information related to this RFP is to be treated with strict confidence. In this regard Respondents are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information related to this RFP or the subsequent contract, written approval must be obtained from Foskop.

7 COMPLIANCE

The successful Respondent [hereinafter referred to as the **Supplier**] shall be in full and complete compliance with any and all applicable laws and regulations.

8 EMPLOYMENT EQUITY ACT

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

9 DISCLAIMERS

Respondents are hereby advised that Foskop is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Foskop reserves the right to:

- 9.1 modify the RFP's Goods/Services and request Respondents to re-bid on any such changes;
- 9.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- 9.3 disqualify Proposals submitted after the stated submission deadline [closing date];
- 9.4 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 9.5 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- 9.6 split the award of the contract between more than one Supplier/Service provider, should it at Foskop's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 9.7 cancel the bid process;
- 9.8 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Foskop to do so;
- 9.9 request audited financial statements or other documentation for the purposes of a due diligence exercise;
- 9.10 not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provided for it;
- 9.11 to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;
- 9.12 to award the business to the next ranked bidder, provided that he/she is still prepared to provide the required Goods at the quoted price, should the preferred bidder fail to sign or commence with the contract within a reasonable period after being requested to do so. Under such circumstances, the validity of the bids of the next ranked bidder(s) will be deemed to remain valid, irrespective of whether the outcome of the tender has been published the outcome of the bid process on the National Treasury e-tender Portal and Foskop website. Bidders may therefore be requested to advise whether they would still be prepared to provide the required Goods at their quoted price.

Note that Foskop will not reimburse any Respondent for any preparatory costs or other work performed in connection with its Proposal, whether or not the Respondent is awarded a contract.

10 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Foskop's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

11 SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

12 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids. Business may not be awarded to a Respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.

13 TAX COMPLIANCE

Respondents must be compliant when submitting a proposal to FOSKOR and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

SECTION 3: BACKGROUND AND SCOPE OF REQUIREMENTS

1 BACKGROUND

The Secondary hoppers has been in operation since the 70's and the structures have been exposed to severe wear and corrosion such that the integrity of the structures is now compromised. Recently, Secondary 2 hopper had to be reconstructed after structural failure, and hence the need to continue with the refurbishment program on Secondary 1 hopper to prevent similar failure from re-occurring.

The targeted refurbishment scope which is to commence during the second half of 2024 at the earliest award of the contract. It must be noted that the execution of the scope is based on original drawings which are in TIFF format, and as such details may be lacking for accurate construction. It shall be the contractor's responsibility to interpret all as drawings and collect necessary information to enable refurbishment of the hopper. Such may include scanning of the structures to produce shop details and fabrication drawings as deemed necessary for the execution of the scope.

2 SCOPE OF REQUIREMENTS

a) Preliminaries and Generals

The contractor is to take note that the contract shall follow the FIDIC conditions of contract and Foskor specific terms and conditions provided for during the tendering stage.

- The contractor shall be responsible for all training requirements, site establishment and onboarding, and any necessary facilities to allow for the efficient execution of the project – including ablution, site office, tea/lunch area for the team.
- The contractor is to provide all tools and equipment, such as spades, picks, scraper tools, buckets, safety lines, harnesses, lights, ventilation fans etc. as may be required to ensure thorough and safe cleaning is done for engineering work to be done.
- The cleaning preparation process is critical to the successful execution of the work and all work will therefore be planned on a 24hr basis with teams of shift workers to ensure timeous completion. Close cooperation with the Foskor production team is crucial to achieve this objective.
- The contractor is to pay attention to all the preambles noted on the BOQ provided no error in omission will be entertained in the pricing.

Preparatory Works

The following work shall be included in the preparatory work:

- Installation of all screens, barrier and temporary access control points for the safe execution of the project. A clear distinction must be made between operational areas and construction site.
- Creating of openings for access purpose into confined spaces by way of cutting, unbolting, etc
- Removal of all covering, sheeting, and flashing and the like.
- The contractor must take all precautionary measures to ensure that bin 1 is completely sealed at the discharge chute to prevent rocks from landing into the bin being worked on while the Hopper 2 is in operation (see section d for illustrative pictures)
- Clearing and cleaning of dead ore inside the hopper to allow proper access to the structures to be inspected and refurbished.
- Careful removal of all suspended floors and the like, including checkered plate as specified in the provisional bill provided.
- Removal of remaining structural elements and mechanical fittings, including dust extraction, vibrating feeders, spile bar frames, chutes and structural beams.
- All materials that can be salvaged shall be carefully removed for decision to be reused by the client. This item is

indicated as such in the BOQ.

- The contractor shall remove each bolt by means of nut splitter tool and punches. A maximum of two bolts can be removed on either side of the connection at a time. Allow for multiple teams where possible to progress work faster.
- Hot work (i.e. oxyacetylene) shall be carefully executed around the main columns to prevent damage.

Main Works – Refurbishment of the Bin

For the purposes of this scope, the Main Works shall refer to all activities and supplies necessary to restore the hopper condition to its original state. The contractor shall supply all plates and rail liners, including chromium carbide liners, and steel sections necessary to execute the works. The contractor shall take particular note of preambles notes on the provisional BOQ to ensure that all items of expense are catered for. The following items are included in the scope of the main works:

- Construction of the complete discharge chute including all beams, plates, stiffeners, rail liners and fasteners required. The chute drawing will be provided in general arrangement, and as such as-build or details must be gathered from site.
- The contractor shall repair 2 off fabricated sections (i.e. main hopper beams) that are attached to the discharge chute. Refer attached provisional bill. See figure 3 below.

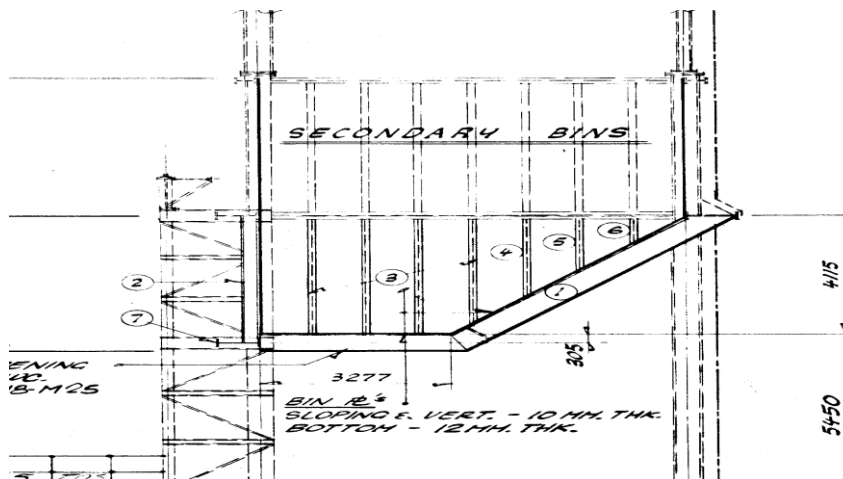


Figure 1: Illustration of the hopper carrier beam

- All floor lining shall be inspected and replaced as necessary using rail liners constructed onto the platework. The active wear areas of the bin shall be lined with rail liners as like for like. Where the 9.8 kg/m rail cannot be sourced, it shall be replaced with suitable nearest size (e.g. 15 kg/m). Such must be specified on the BOQ. The panels shall be constructed for ease of rigging and handling as contemplated by the BOQ.
- Allowance should be made for replacement of divider wall corroded beams and installation of new plate work, including lining thereof.
- All damaged checkered plate and supports shall be repaired as far as per estimates provided. The client engineer shall guide in terms of section to be renewed that exceed the bill upon assessment.
- Cutting and preparation of the plates according to specific sizes taken shall be done at the contractor's premises. These plates shall be marked for easy identification and installation in the correct sections. All plate work around the bin is envisioned to be renewed. Some materials left over from previous project shall be free issued after assessment.
- The pre-drilling of holes and packing of liners shall be done prior to installation at the contractor's premises.
- The contractor shall supply all bolts and nuts for the main installation.
- Care must be taken to minimise wastage as far as possible and any such wastage as deemed avoidable by the engineer shall be for the contractor's account.

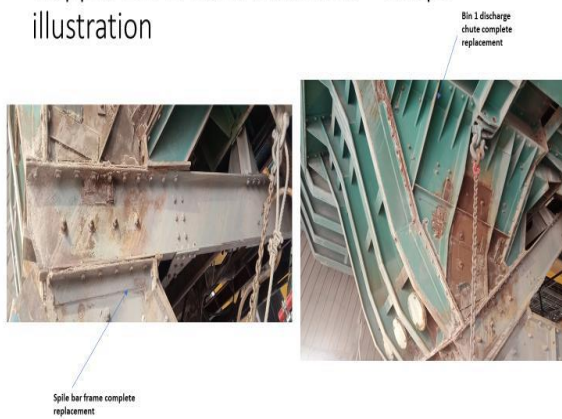

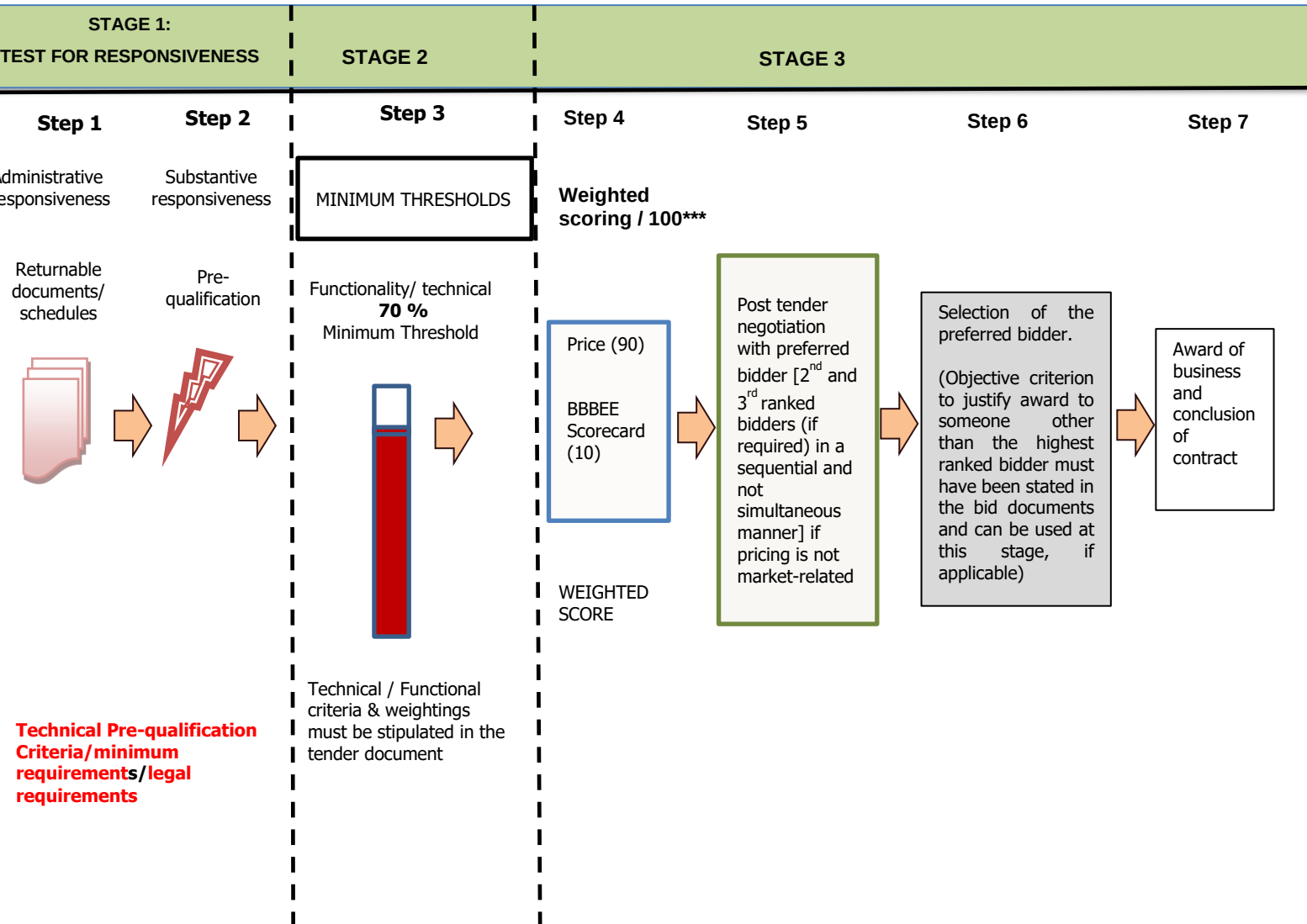

THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME**INTRODUCTION**

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIPP requirements. NIPP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

1. PILLARS OF THE PROGRAMME

- 1.1 The NIPP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$5 million or other currency equivalent to US\$5 million will have a NIP obligation. This threshold of US\$5 million can be reached as follows:
- (a) Any single contract with imported content exceeding US\$5 million.
 - or
 - (b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$3 million awarded to one seller over a 2 year period which in total exceeds US\$5 million.
 - or
 - (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$5 million.
 - or
 - (d) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US\$5 million.
- 1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30% of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIPP obligation on a *pro-rata* basis.
- 1.3 To satisfy the NIPP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.
- 1.4 A period of seven years has been identified as the time frame within which to discharge the obligation.

2. REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R10 million** (ten million Rands), submit details of such a contract to the DTI for reporting purposes.
- 2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1.(b) to 1.1. (d) above.

3. BID SUBMISSION AND CONTRACT REPORTING REQUIREMENTS OF BIDDERS AND SUCCESSFUL BIDDERS (CONTRACTORS)

- 3.1 Bidders are required to sign and submit this Standard Bidding Document (SBD 5) together with their bid documentation at the closing date and time of the bid.
- 3.2 In order to accommodate multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as indicated in sub-paragraphs 1.1 (b) to 1.1 (d) above and to enable the DTI in determining the NIPP obligation, successful bidders (contractors) are required, immediately after being officially notified about any successful bid with a value in excess of R10 million (ten million Rands), to contact and furnish the DTI with the following information:
 - Bid number;
 - Description of the goods or services;
 - Date on which the contract was awarded;
 - Name, address and contact details of the contractor;
 - Value of the contract; and
 - Imported content of the contract, if possible.
- 3.3 The information required in paragraph 3.2 above must be sent to the Department of Trade and Industry, Private Bag X 84, Pretoria, 0001 for the attention of Mr Elias Malapane within five (5) working days after award of the contract. 4. PROCESS TO SATISFY THE NIPP OBLIGATION

- 4.1 Once the successful bidder (contractor) has made contact with and furnished the DTI with the information required, the following steps will be followed:
 - a. the contractor and the DTIC will determine the NIPP obligation;
 - b. the contractor and the DTI will sign the NIPP obligation agreement;
 - c. the contractor will submit a performance guarantee to the DTI;
 - d. the contractor will submit a business concept for consideration and approval by the DTI;
 - e. upon approval of the business concept by the DTI, the contractor will submit detailed business plans outlining the business concepts;
 - f. the contractor will implement the business plans; and
 - g. the contractor will submit bi-annual progress reports on approved plans to the DTI.

- 4.2 The NIPP obligation agreement is between the DTI and the successful bidder (contractor) and, therefore, does not involve the purchasing institution.
