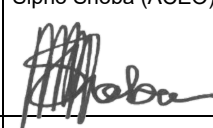

Single source: Single-Source Procurement: Is when there are multiple potential suppliers, but the selection is based on specific criteria (e.g. continuation, compatibility, warranties and guarantees). These may include but not limited to, services such as legal services where a procuring institution may wish to continue with a specific lawyer who is familiar with a legal case; or the procurement of a subscription to a financial journal that provides specific financial content.
