### 3. BACKGROUND

The SABC Platfontein office in the Northern Cape Province is the home for XK-FM, which was officially opened on the 18th of August 2000 at Schmitsdrift, in the outskirt of the Vaal River. In 2005, SABC, who is the mother-body and provider of all logistics to the station, moved the station with the old analogue studio's from Schmitsdrift, and added a new edit suite, and an analogue main control to a new building in Platfontein.

The growth in personnel and production necessitates that the building requires expansion to accommodate all the personnel and the additional equipment. The plan is to add an administration building at the back of the current structure and link the two with a passage. The original structure will be the studio block accommodating all the studios such as main broadcast studio, backup studio, edit suites, digitize main control, and a new drama studio, server room, a TV studio and edit suites for tv and video production, archiving studio, and media library. The admin building will be used for all the admin personnel including the XK-FM station manager and station personnel. It will also house the conference room and news team. The current sanitation infrastructure is no longer adequate. The undersize tank that is being used by Platfontein office cluster requires much more frequent pumping than previous years.

### 4. REQUIREMENTS AND SCOPE OF SERVICES

The service of an Architect as a principal agent to execute the architectural stages 1-6 on the project and include the following services but not limited to:

- Designing building and structure, ensuring functionality, safety, and aesthetic appeal while managing project from conception to completion.
- Concept Development: work closely with client to understand their needs and preferences, developing design concepts that meet project requirements.
- Design and Planning: create detailed architectural plans and drawings, using software tools to visualize the design and ensure compliance with building codes and regulations.
- Project Management: oversee the entire construction process, coordinating with professional contractors, and other stakeholders to ensure that the project is completed on time and within budget.
- Feasibility Studies: Review of existing feasibility study (SABC will provide the existing feasibility study i.e Geo Technical investigation report and the feasibility study) and make recommendation where necessary.
- Collaboration: collaborate with various professionals and appoint relevant professionals deemed necessary for the project, including civil engineers, landscape architects, and urban planners, to integrate different aspects of the project.
- Sustainability Practices: focus on sustainable design, incorporating eco-friendly materials and energy-efficient systems into their projects.
- Client Presentations: present design proposals complete with bill of quantities (BOQ) to clients for approval, making adjustments based on feedback and ensuring that the final design aligns with the client's vision.
- Regulatory Compliance: ensure that all designs comply with local zoning laws, building codes, and safety regulations, obtaining necessary permits before construction begins.

## 5. RFQ Validity period

This bid will remain valid **90 (ninety) days** from the date of closing.

## 6. Costing

The indicative costing should reflect a detailed cost breakdown per individual project stages from 1 - 6, and any direct or indirect costs associated with the rendering of services / supply and delivery of goods.

## 10.3 ADJUDICATION USING A POINT SYSTEM

- The bidder obtaining the highest number of total points will be awarded the contract.
- Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

## 10.4 Objective Criteria

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserve the right not to award this tender to any bidder who fails the financial stability assessment.
- No SABC former employees shall be awarded contracts with the SABC within **12 months** after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of 12 (**Twelve**) months has expired.
- Should the employee be dismissed from the SABC employment, such employee shall be prohibited from conducting business with SABC for a period of **5 (Five)** years from the date of dismissal.
- Should the employee be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any Board member or Board member owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.

## 12. CONDITIONS TO BE OBSERVED WHEN TENDERING

- The corporation does not bid itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.
- **The Corporation reserves the right to:**
  - Make a selection solely on the information received in the submissions
  - Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
  - Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
  - Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BEE & Price.

## 13. Cost of Bidding

- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the

contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses, or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation.
  - (d) recommend that the tenderer or contractor, its shareholders, and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.
