1. PURPOSE

The purpose of the contract is to acquire the professional services of a consultant, with extensive experience and technical competency to conduct environmental audits, collection of samples for underground and surface water monitoring, leachate and gas monitoring, air space assessment to determine the remaining useful lifespan of operational landfills, assessment and calculation of buffer zone encroachment and calculation of landfill provisions at the City of Tshwane landfill sites.

2. BACKGROUND

The City has a total of ten (10) landfill sites, with four being operational and the remaining six (6) closed. The below table provide details of the landfill sites:

The required services are guided by the mandatory requirement to ensure that the City's landfill sites comply with requirements contained in "The Minimum Requirements for Disposal of Waste by Landfill, The Minimum Requirements for Water Monitoring at Waste Management Facilities (DWAF, 1998), The Accounting Standards Board Guideline on Accounting for Landfill Sites (ASB, 2019), as well as other relevant regulatory framework.

3. DESCRIPTION OF SERVICES REQUIRED

3.1. Water Quality Monitoring

The consultant is required to carry out analysis of ground and surface water on each site as prescribed by the Minimum Requirements issued by Department of Environment and Water Affairs (DWA), 1998. The ultimate goal for monitoring is to establish the trends in water quality and determine possible pollution which may be as a result of day to day operations of the landfill site and post closure. Section 7 of the Minimum Requirements for Water Monitoring at Waste Management Facilities (Second Edition 2008) describes the Analytical Variables which are suggested in a comprehensive analysis and an indicator analysis.

Ground and surface water samples should be submitted to an SANAS accredited laboratory.

3.2. Leachate Monitoring

The service provider will be required to identify possible indicators for leachate generation on all sites. Where leachate samples are collected must be submitted to SANAS accredited laboratory for analysis. Provide leachate sampling results with detailed interpretation report.

In instances that evidence of amounts of leachate generation is present and has potential to cause detrimental effects on the surrounding water sources, prepare a leachate management plan to contain and control further spread of the contamination.

3.3. Air Quality Monitoring

The consultant will be required to investigate the dispersion of landfill gas (methane, VOC, H₂S), landfill odours, dust and other applicable air quality variables and provide recommendations to remedy of any non-compliances which may be found as a result of the analysis.

3.4. Airspace Assessment

The consultant will be required to conduct a waste volume survey to determine the landfill airspace and the remaining useful lifespan of the remaining permitted four (04) operational landfill sites. The assessment must also include measurements of the height at which the active waste beam is being operated to establish if the height complies with the maximum permitted height restriction for the landfill sites under survey.

3.5. Landfill Provision Calculations

The service provider will be required to calculate and prepare the landfill provision quantum report for both operational and closed landfill site in accordance with the guidelines provided by the Accounting Standards Board Guideline on Accounting for Landfill Sites (ASB, 2019). The report must include the calculations for the present and future value projections for the assets under assessment.

3.6. Environmental Audits

The service provider will be required to conduct an environmental audit and compile an audit report documenting the findings and provide the extent of compliance with the conditions set out in the operating permit of the landfill site and other relevant regulatory framework. The environmental audit must also include assessment of the landfill buffer zone and report the extent of encroachment where found. The environmental audits to be conducted for each site, both operational and closed landfill sites.

4. PROJECT SCOPE

The professional services and scope required comprise of disciplines from Environmental Management, Geohydrologists and related studies. The consultant will be required to perform, amongst others, the following duties:

4.1. Water Quality and Leachate Monitoring

- a. Bi – annual groundwater and surface water monitoring as described in the Minimum Requirements issued by the Department of Water and Environmental Affairs (DWEA), should be conducted at the end of the dry (September) and wet (April) seasons respectively.
- b. Reports on the existing groundwater and leachate monitoring must be submitted after each monitoring period and the report will be submitted to DWA, GDARD and the City within 30 days from the date on which the consultant finalized the assessment.
- c. Study all existing sampling reports to build up a continuous trend of current as well as future results relating to the ground water, surface water and leachate monitoring.
- d. Provide recommendations on additional borehole requirements as well as leachate monitoring systems at all landfill sites.
- e. Each individual sites should be reported separately in terms of the following main points: Number and condition of monitoring points, Ground and surface water chemistry, Recommendations for further work, 10 x Hard copies of the report required, Electronic version (on USB X10) of report required.

4.2. Air Quality Monitoring

- a) Conduct an investigation on the dispersion of landfill gas (methane, VOC, H₂S), landfill odour, dust and other air quality variables.
 - Samplers for Methane, VOC, H₂S (8 samples for each gas per site).
 - Dust monitoring (to cover 8 sampling points per landfill site) to be conducted twice per year for 30 days each cycle.
- b) Provide recommendations to be taken to address these nuisances.
- c) Reports on the air quality monitoring will be submitted to GDARD and the City within 30 days from the date on which the external auditor finalized the assessment
- d) Each individual sites should be reported separately in terms of the following main points: Number and condition of monitoring points, Air quality chemistry and dispersion model and trends, Recommendations for improvement, 10 x Hard copies of the report required, Electronic version (on USB x10) of report required

4.3. Airspace Assessment

- a. Compile the waste volume survey and project the remaining useful lifespan for

- each site
- b. Present data on the type of waste disposed per site and the footprint of the area turned versus the remaining undeveloped cells per landfill site
 - c. Present the airspace assessment for each site under study and indicate the expected year of decommissioning for each site
 - d. Present the topographical surveys as well as the electronic models and drawings illustrating the design layout of the permitted future shape of the landfill site
 - e. Provide detailed report on landfill buffer zone encroachment and schematic presentation of the areas affected
 - f. Reports on the airspace assessment must be submitted to the City within 30 days and it will be submitted to GDARD from the date on which the consultant finalized the assessment
 - g. Each individual sites should be reported separately and copies of the report must be provided as follows: 10 x Hard Copies of the report required, Electronic version (on USB x10) of report required.

4.4. Landfill Provision

- a. Compile a landfill provision report with calculations for the City's ten (10) landfill sites
- b. Report must contain provisioning for present and future value liabilities for rehabilitation, maintenance and monitoring of the sites under survey
- c. Landfill provisioning report to be prepared for the financial year in review (2023/24).
- d. Reports on the landfill provision quantum will be reviewed by AGSA during 2023/24 audit cycle.
- e. Each individual sites should be reported separately, and copies of the report must be provided as follows: 10 x Hard Copies of the report required, Electronic version (on USB x10) of report required.

4.5. Environmental Audits

- a. Compile an audit report documenting the findings of the audit
- b. Establish whether the conditions of the permit are adhered to
- c. Specify non-compliances identified and rectified prior to the audit
- d. Interpretation of all available data regarding the operation of the facility
- e. Present monitoring data graphically and outline trend analysis variations
- f. Specify target dates for the implementation of the recommendations to achieve compliance
- g. Reports on the external environmental audit must be submitted to the City within 30 days and it will be submitted to GDARD.
- h. Each individual sites should be reported separately, and copies of the report must be provided as follows: Hard Copies of the report required, Electronic version (on

USB x10) of report required.

5. DELIVERABLES

On monthly basis, the successful bidder must submit monthly report outlining performance progress of the project.

6. Team members will include any other qualified person who will be part of executing some of the tasks and they are as follows:
 1. Environmental auditor who will be conducting the landfill audit
 2. An environmental specialist who will be assigned to collect waster samples
 3. A specialist who will be assigned to conduct air quality monitoring and collect the necessary data
 4. A qualified person who will be assigned to conduct airspace assessment
 5. A qualified person who will be assigned to prepare the landfill provision quantum report as well as assessment of landfill buffer zones.
 6. A laboratory analyst who will be appointed to analyse samples submitted at the laboratory for analysis

7. VALIDITY PERIOD

The validity period for the quotation after closure is 90 days.

8. STAGES OF EVALUATION

This bid will be evaluated in three evaluation stages namely:

- **Stage 1:** Administrative compliance
- **Stage 2:** Mandatory
- **Stage 3:** Preference Points System
