In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), bids are hereby invited for the **Operation and Maintenance of The Kinross Waste Disposal Site for A Period Of 36 Months**

Tender documents and specifications are available and will be sold at a **non-refundable fee of R1000.00 per document from the 11th of November 2024**. Tender documents will be sold at the cashiers by the cash point at Secunda Main Municipal offices.

The closing time for receipt of BIDS is **12:00hrs** on **11/12/2024**. Telegraphic, e-mail, unmarked and **late bids** will under no circumstances be considered and accepted. The quotation/bid box will be emptied just after closing time on the closing date. Hereafter all bids will be made public.

Fully completed bid documents, clearly marked “Bid No: **8/3/1-8/2023: OPERATION AND MAINTENANCE OF THE KINROSS WASTE DISPOSAL SITE FOR A PERIOD OF 36 MONTHS** with “**NAME OF SUPPLIER**” must be placed in a sealed envelope and placed in the tender box at **Secunda Head Office, Horwood Street, CBD Secunda, 2302** by no later than 12h00 on **11/12/2024**. The envelope must be endorsed with number, title and closing date as indicated above.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Local Municipality where 80 points will be allocated in respective of price and 20 points for a specific goal. Govan Mbeki Municipality Supply Chain Management Policy allocate 20 points to race (6), people with disability (4), youth (4), woman (4) and Implementing reconstruction and development programe (2).

No awards will be made to a person:

- Who is not registered on the Central Supplier Database
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.



The municipality reserves the right to withdraw any invitation to bid and/or to re-advertise or to reject any bid or to accept a part of it. The municipality does not bind itself to accepting the lowest bid or award a contract to the bidder scoring the highest number of points.

The following documents have to be attached (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- **Copy/ print Tax Compliance status pin issued by SARS - Compulsory**
- **Copy of company's current municipal account or all its directors (not older than 3 months and not owing for more than 3 months) or copy of Valid Lease Agreement, with statement from the landlord – Compulsory**
- **Valid CSD summary report – Compulsory**
- **Joint Ventures Agreement (in case of a Joint Venture) – Compulsory**
- **Letter of Good Standing/Workmen's Compensation for Occupational Injuries and Diseases (COIDA) - Compulsory**
- **Public Liability Insurance. Minimum R5M - Compulsory**
- **Three Years Audited Annual Financial Statements, for bids above R10m (This only applies to bidders who are required by law to submit annual financial statements) - Compulsory**
- **All forms must be filled in full – Compulsory**

FORGERY OF DOCUMENTS

- **Bidders that are found to have submitted forged or false documents as stipulated above, will not just be eliminated, but will also be reported to National Treasury and backlisted from doing business with the Municipality.**
- **Those bidders will be listed on National Treasury database of restricted service providers from doing business with Government.**
- **Fraud and criminal cases can also be open with SAPS.**
- **Bidders are therefore advised and encouraged to submit true and correct documents.**
