1. INTRODUCTION

1.1 INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve OHS conditions in South African Mining Industry.

The MHSC will be hosting the 2024 Occupational Health and Safety (OHS) Summit, in line with its mandate as provided for in Section 43 (e) of the Mine Health and Safety Act (MHSA). This significant event will provide a platform to reflect on the progress made towards achieving the 2014 mining industry OHS Summit milestones and to discuss future strategies to enhance the health and safety performance within the mining sector. A Summit action plan will be developed by all stakeholders to address current and emerging health and safety challenges in the mining industry.

2. PART A: THE CONTRACT

2.1 CONTEXT OF THIS PROCUREMENT



The MHSC seeks to appoint of a service provider for a two and half day conferencing venue package for the occupational health and safety summit taking place from the 16th to 18th of October 2024, in Gauteng.

2.2 CONTRACT PERIOD

The duration will be valid for a once-off period.

2.3 TERMS OF REFERENCE

2.3.1 DETAILED SCOPE OF WORK

1.1 Detailed Scope of work:

The detailed scope of work is as follows:

- a) The MHSC requires a two and half (2½) days conferencing venue package from the 16th to 17th (full day) and 18th (half day) of October 2024.
- b) The conference venue should have the seating capacity to hold one thousand eight hundred (1800) delegates.
- c) The conferencing venue must be big enough to allow exhibition space for roughly 30 exhibitors at a minimum size of 6 meters X 3 metres shell schemes stands. The space should big enough to accommodate multiple tea stations.
- d) Capacity to hold ten breakaway sessions are required on the 17th of October 2024.
- e) Various rooms will be required, namely Ministerial holding room, Medical room, operations room and media brief room.
- f) Audio visual and sound system required to allow for streaming services in the conference venue and breakaway sessions.
- g) Capacity to host a summit gala dinner on 17 October 2024 taking note of following requirements:
 - Venue for summit gala dinner within the same premises.
 - Estimated number of 1800 delegates are expected to attend.

- Set-up and decor is required (i.e. tablecloths, centre pieces, underplates, etc).
- Audiovisual and sound for presentations and background music to be provided (sound technician required).

- h) The venue must have uninterrupted power supply (UPS).
- i) Provision to be made for setting-up the day before the event is required (the 15th of October 2024).
- j) All meals to accommodate vegetarians, kosher, halaal, and vegans.

1.2 Special Conditions:

- The bidder will be required to ensure that the conference venue is setup at least a day before the commencement of the summit to the specification of the MHSC.
- The bidder will be required to allow exhibition stands (shell schemes) to be erected a day before the commencement of the summit to the specification of the MHSC.

4.1.3 Bid documents must contain both technical proposal and pricing proposal.

These serve as the original sets of bid documents and form part of the contract.



4.2 BID CLOSING

- 4.2.1 There shall be no public opening by the MHSC of the bids received.
- 4.2.2 There shall be no discussions with any enterprise until evaluation and adjudication of the proposal has been complete.
- 4.2.3 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, bids submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.
- 4.2.4 All bids shall close on the specified date and time as stipulated in the bid document.
- 4.2.5 Bids received after closing time and date will be classified as LATE and will not be considered.
- 4.2.6 Bids submitted in any other manner other than the specified address (tender box) shall not be accepted.

4.3 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the Bid documents.

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.

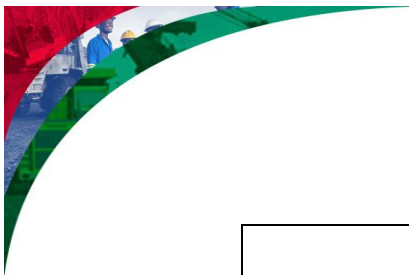

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

The Mine Health and Safety Council (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). The Mine Health and Safety Council (MHSC) appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
