Background

Johannesburg City Parks and Zoo (JCPZ) is a non-profit company, registered as a municipal entity under the City of Johannesburg (CoJ) Municipality.

Until the 2019/20 financial year, JCPZ had no material adjustments to the annual financial statements in the three (3) years prior including achievement of clean audit opinions in both 2016/17 and 2017/18 financial years.

The management of JCPZ aims to improve on the prior year's outcome.

In an effort to achieve this outcome, JCPZ requires professional assistance from the panel of the professional service providers in reviewing and preparations of some sections of the annual financial statements for the year-ended 30 June 2021.

The service provider will be required to pay special attention to the property, plant and equipment, accounting for living and non-living resources (animals etc.) as well as the application of GRAP 18 (segment reporting).

Project Purpose

The purpose of the project is to support the management of JCPZ in the preparations and/or review of the GRAP compliant annual financial statements with special focus on Property plant and equipment, accounting for living and non-living resources (animals etc.) as well as the application of GRAP 18 (segment reporting), amongst others (See scope below for details) before submission to the Auditor General of South Africa (AGSA) on the 31st August 2021.

- 2.7 “**consortium or joint venture**” means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 “**EME**” means any enterprise with an annual total revenue of R5 million or less .
- 2.10 “**Firm price**” means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 “**functionality**” means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 “**non-firm prices**” means all prices other than “firm” prices;
- 2.13 “**person**” includes a juristic person;
- 2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 “**sub-contract**” means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
