Terms of References (TOR)

NWHC 01/2021: PROVISION OF OFFICE PREMISES IN MAFIKENG

1. INTRODUCTION

The North-West Housing Corporation (NWHC) is a Schedule 3(c) entity established in accordance with the Public Finance Management Act, no 1 of 1999 (PFMA) as amended. It is a Housing development arm of the NW Department of Human Settlements and has in recent period identified specific zones within the province where the demand for adequate housing has remained high; despite the delivery of subsidized housing in these areas, population growth has not kept pace with housing demand and new household formation.

The North-West Housing Corporation (NWHC) currently owns and occupies the Segarona Building, No. 23 First Street, Industrial Site, Mafikeng.

The corporation needs to move temporarily to a secure, public accessible, structurally sound, compliant, safe building and environment.

2. PURPOSE

This bid has a dual purpose as NWHC firstly requires to secure adequately, suitable and OHSA compliant office space, within the Mahikeng / Mmabatho CBD and secondly requires the landlord to administer the Tenant Installation in accordance to NWHC requirements.

3. LEGISLATIVE CONSIDERATIONS

The service provider must maintain deliverables in compliance with, but not limited to the following legislation as amended:

- (i) Constitution of the Republic of South Africa Act 108 of 1996
- (ii) Occupational Health and Safety Act 85 of 1993 and Regulations (as amended)
- (iii) National Building Regulations and Standards Act 103 of 1977 (as amended)
- (iv) Relevant SANS Standards and
- (v) B-BBEE Act, No. 53 of 2003 (as amended)

4. SCOPE OF WORK AND DELIVERABLES

4.1 SPECIFICATION FOR OFFICE SPACE

4.1.1 LEASE:

4.1.1.1 The lease period should be for a maximum of two (2) years.

- 4.1.1.2 Further, the contract should include the option of a further extension of the accommodation as will be negotiated, for on a month-to-month basis.
- 4.1.1.3 North-West Housing Corporation (NWHC) will be under no legal obligation to renew the lease upon expiration.
- 4.1.1.4 The lease offered must provide for building maintenance by the lessor / landlord as part of the lease.
- 4.1.1.5 The lease contract should be signed with the owner of the building/ landlord, otherwise by a legally delegated representative chosen by owner.

Note!!!: A signed and endorsed Draft Lease Proposal is to be submitted for consideration in this bid.

4.1.2 OCCUPANCY:

- 4.1.2.1 The accommodation must be an existing building, ready for occupancy immediately after **completion of the tenant installation and network infrastructure** or **in less than 2 months** by the North-West Housing Corporation (NWHC).

4.1.3 BUILDING:

- 4.1.3.1 The building must be an ***existing building*** (*complete built structure*).
- 4.1.3.2 ***Building Insurance*** is the responsibility of the landlord and must be always kept up to date throughout the duration of the lease contract.
- 4.1.3.3 ***Proof of Building Insurance*** is to be shared with NWHC for transparency and record.
- 4.1.3.4 A building with a green rating would be advantageous.

- 4.1.4 **SIZE:** The Gross Lettable Area (GLA) must include **2300m² to 3000m²** assignable space and exclusive of non-assignable office space.

- 4.1.5 **GRADING:** Proposals must indicate the grade of the building (*P, A, B or C grade space*) on the comparative accommodation grading scale.

- 4.1.6 **LOCATION:** The office space must be within the areas of Mafikeng or Mmabatho CBD.

4.1.7 ACCESSIBILITY:

- 4.1.7.1 The building should allow for comfortable entrance / exit to and from the building by staff, clients and service providers.
- 4.1.7.2 The building must make provision for access control which must be accessible to both staff and service providers.

4.1.8 FACILITIES:

- 4.1.8.1 Ablution facilities accommodating for both Female and Male.
- 4.1.8.2 Ablution facilities for the physically disabled males and females must be available.
- 4.1.8.3 The office space must also have a fully fitted kitchen (*e.g., sink, drainage, taps, cupboards, etc.*)

4.1.9 BRANDING:

4.1.9.1 The NWHC shall reserve the right to place exterior and interior signage, including painting in corporate colours.

4.1.10 RECEPTION AREA:

4.1.10.1 The Reception Area where the clients of NWHC will be assisted, compels for the NWHC Branding, look and feel as per the material samples and specifications to be provided to the successful bidder and Compulsory Bid Briefing Session to be held with potential bidders.

4.1.11 SHOP FRONT:

4.1.11.1 The shop front windows and doors are to be secured by a roller-shutter gate to secure the premises, personnel and assets when required and afterhours.

4.1.12 NOISE REDUCTION AND CONTROL:

4.1.12.1 The noise levels within the front office need to be maintained at an acceptable level between 40 and 60 decibels as external noise needs to be reduced to an acceptable level.

4.1.13 PARKING: Minimum of Thirty-Five (35) secure covered parking bays, Ten (10) open parking bays and two (2) disabled persons parking bays. All parking bays must be on the premises.

4.1.14 STORAGE: Provision of one (1) strong room with a minimum size of 15m².

4.1.15 COMPLIANCE:

4.1.15.1 Appropriate and building regulation safety signage must be in place.

4.1.15.2 The accommodation must provide lighting as per building regulation.

4.1.15.3 Compliance with emerging changes to applicable legislation that affect the building shall be the sole responsibility of the landlord at no cost to the North-West Housing Corporation (NWHC).

4.1.15.4 The Corporation may and will require the landlord to adhere to applicable legislative requirements to maintain compliance.

4.1.16 ACCESS TO PERSONS WITH DISABILITIES:

4.1.16.1 The accommodation must be prepared for access for persons with disabilities as prescribed in legislation.

4.1.17 SAFETY: The accommodation must be in compliance with all applicable legislation that regulates buildings, safety and emergency issues.

4.1.18 SECURITY:

4.1.18.1 The accommodation must be located within a publicly and generally safe area.

4.1.18.2 The premises must have an existing guardhouse with the following:

- (i) Minimum size to be 4x4 meters or more.
 - (ii) Bullet-proof window (*Preferrable*)
 - (iii) Burglar bars with hinges on the windows.
 - (iv) Toilet facility on guardhouse or located not far from it and be easily accessible.
-

4.1.18.3 The premises must be fenced, with minimum of two (2) entrance gates with motor gates and remote controls.

4.1.19 AMENITIES:

4.1.19.1 The accommodation must be a clean and conducive environment and facilities, cleaning and hygiene services well managed and maintained.

4.1.20 POWER:

4.1.20.1 The space(s) on offer must have own electric distribution board(s).

4.1.20.2 A separate electrical meter reader will be an advantage and enable NWHC to manage, monitor and implement power saving initiatives.

4.1.20.3 NWHC will provide its own Back-Up Generator Power Supply which the landlord will co-arrange for its installation for in the event of power failure for the entire building.

4.1.20.4 The certified installation contractor must issue a Certificate of Compliance for installation and connection to both NWHC and landlord.

4.1.20.5 Trunking is to be installed to run both power and networks cabling separately.

4.1.20.6 Adequate power points are to be provided within trunking or conduits for the electrical equipment and include additional points to cater for the computer hub-switch gear, workstations, printer, etc.

4.1.21 SERVER ROOM:

4.1.21.1 Provision must be made for a server room with full requirements as per server room specifications which include, but not limited to, Air-Conditioning, Fire-Resistant (Dry) Walling, Fire Door, Raised Floor, etc.

4.1.21.2 Also, trunking is to be installed to run both power and networks cabling separately.

4.1.22 WATER:

4.1.22.1 The accommodation must have a clean and constant supply of water with hydroboil(s) in the kitchen(s).

4.1.22.2 There must be an emergency water supply for when the normal supply is cut for whatever reason (*e.g., borehole, municipal ring supply, tinkering, etc.*).

4.1.23 MAINTENANCE:

4.1.23.1 The landlord shall be responsible for the normal day-to-day electrical, plumbing, air-conditioning and general building repairs and maintenance to ensure a safe and conducive working environment. (*This is to be included in the lease*).

4.1.24 AIR-CONDITIONING AND VENTILATION:

4.1.24.1 The office accommodation must be fully air-conditioned and ventilated.

4.1.24.2 Air conditioning units shall be maintained and serviced as per manufacturer's specifications at the account of the landlord.

4.1.24.3 Windows must have blinds and minimum 50% openable.

4.1.25 FIRE PREVENTION/DETECTION:

(i) The bidder must submit **Certificates of Compliances** in relation to:

- a. Fire Safety,
 - b. Fire Detection System,
 - c. Safe Occupancy and
 - d. Electrical Compliance
- (ii) on an annual basis for the duration of the lease contract.
- (iii) Logistics and costs of the process are the responsibility of the landlord.
- (iv) The accommodation must be complying, in respect of all National Building Regulations, SANS 10040, as amended and Fire and Local Municipal Fire Legislation, Regulations, etc. and the minimum requirement being that a "smoke detection system" to be fitted, linked to the Landlords (24) hour security control room.
- (v) All fire equipment, including the "portable" fire equipment, needs to be provided and maintained by the landlord as part of the lease.
- (vi) All fire equipment, including the "portable" fire equipment, needs to provide and maintained by the landlord as part of the lease.
- (vii) All Signage must be installed, be visible and compliant with OHS requirements.

4.1.26 FLOOR PLAN: A scaled floor plan of the building must be issued.

4.2 CONFLICT OF INTEREST

Service providers are required to provide services that are professional, objective and impartial.

Service providers must ensure that there is no conflict of interest between existing assignments, obligations and responsibilities to other clients and the services set out in these Terms of Reference.

In the event of any uncertainty in this regard, full disclosure in the submitted proposal should be considered.

Non-disclosure of a conflict of interest may be grounds for disqualification from bidding and/ or termination of any contract.

4.3 CONFIDENTIALITY AGREEMENT

The successful service provider may have access to confidential data or information.

Bidders must submit a signed Non-Disclosure Agreement of North-West Housing Corporation (NWHC) which shall be binding.

4.4 ENVISIONED TIMEFRAMES FOR OCCUPANCY

The proposed accommodation should be ready for occupancy as soon as Tenant Installations are completed, for North-West Housing Corporation (NWHC) to occupy the premises, but not later than 01 August 2021, subject to negotiation on tenant installation allowance or beneficial occupation.

4.5 PRICING AND PRICE ESCALATION

The bidding price must be quoted per meter squared (m2) .

All prices must be VAT inclusive and quoted in South African Rands;

The escalation percentage (%) per year, must be clearly indicated without hidden costs and this must be inclusive for the duration of the contract period.

The lease offer must also include general day-to-day building maintenance required to ensure a safe and conducive working environment.

No payment will be made in excess of the agreed to and contracted square meterage. The lease offer must indicate the allowance for tenant's installation.

NB!!! A signed and endorsed draft lease proposal is to be submitted for consideration in this bid.

5. GENERAL

- 5.1 Potential bidders will be provided information regarding the tenant fit-out, branding, etc. required for the NWHC office upon successful bid.
- 5.2 Bids to include a floor sketch, pointing out the allocated office space and floor, accessibility to Persons with Disability, 24 hours security control room and current rent roll list.
- 5.3 The successful bidder will be required to provide a detailed space plan drawing, for sign-off by NWHC and on which the contractor is to execute the tenant fit-out. The fees associated to this, should be included in the actual bid pricing schedule.
- 5.4 Should the bidder decide in future to sell the building to another company while in contract with NWHC and the new owners decide to evict NWHC, the bidder shall be liable for the refund of the tenant installation and other associated costs.

6. Evaluation Process

The evaluation will be completed in 4 phases:

- Phase 1: Compliance to Minimum Requirements
 - Phase 2: Functional Evaluation
 - Phase 3: Site Visit and Presentation by The Bidders
 - Phase 4: Pricing and Preferential Procurement Policy

Phase 1: Compliance to minimum requirements

During phase 1, all bidders will be evaluated to ensure compliance to minimum document requirements (eg. *Tax Clearance Certificates*), ensuring all documents have been completed and that the specified documentation has been submitted in accordance to the bid requirements.

All bidders that comply with the minimum requirements will advance to Phase 2.

Responsive Criteria: Failure to provide the following might results in a bid not to be considered:(minimum requirements)

- a) Bid offers must be properly received on tender closing date and time specified on the invitation.
 - b) Fully completed and signed in ink as per Standard Conditions of Tender.
 - c) Submission and completion of the Declaration of Interest.
 - d) Submission of a valid original Tax Clearance Certificate from SARS.
 - e) Submission of the company`s registration certificate from Register of Companies.
 - f) Submission of a confirmation of registration with the National Treasury Central SuppliersDatabase (CSD).
 - g) Company Profile
 - h) BBBEE Certificate

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.

Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- 1.13 “Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 “GCC” means the General Conditions of Contract.
- 1.15 “Goods” means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 “Imported content” means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 “Local content” means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 “Manufacture” means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 “Order” means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 “Project site,” where applicable, means the place indicated in bidding documents.
- 1.21 “Purchaser” means the organization purchasing the goods.
- 1.22 “Republic” means the Republic of South Africa.
- 1.23 “SCC” means the Special Conditions of Contract.
- 1.24 “Services” means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

Use of contract documents and information; inspection. | <p>5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.</p> <p>5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.</p> <p>5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.</p> <p>5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.</p> |

| 7. Performance security | <p>7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.</p> |

- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

**8. Inspections,
tests and
analyses**

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with

supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and

- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard

the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security,

damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

**26. Termination
for insolvency**

- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

**27. Settlement of
Disputes**

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier.

**28. Limitation of
liability**

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

		(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
29. Governing language	29.1	The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law	30.1	The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31. Notices	31.1	Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
	31.2	The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
32. Taxes and duties	32.1	A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
	32.2	A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
	32.3	No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
33. National Industrial Participation Programme	33.1	The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
