SPECIFICATIONS FOR REMOVAL OF GENERAL WASTE FROM iThemba LABS, CAPE TOWN

PURPOSE

The purpose of this document is to outline the requirements for the removal and disposal of general and other waste streams. The contract will span over 3 years (36 months).

SCOPE

This agreement shall apply to the iThemba LABS Site in Faure / Eerste River, Cape Town.

LEGAL REQUIREMENTS

The service provider will be required to comply with the following Legislation / Regulatory requirements:

- 1) National Environmental Management Act: no. 107 of 1998 (NEMA)
- 2) National Environmental Management: Waste Act no. 59 of 2008
- 3) Occupational Health and Safety Act: no. 85 of 1993 (OHSA)

The service provider must provide the following documents / information:

- 1) IPWIS Registration: <http://ipwis.pgwc.gov.za/ipwis3/public>
- 2) Proof of registration as an Official Waste Management Service Provider.

WASTE RECEPTACLES

The service provider will be required to provide 2 x 6m³ (REL) waste collection skips, in reasonable condition as specified by the National Environmental Management: Waste Act no. 59 of 2008, Part 5: Storage, Collection and Transportation of Waste, which will be placed at the general waste storage area/s behind our UPS building or at the MRD facility.

COLLECTION, TRANSPORT AND DISPOSAL

The collection and transport of waste from iThemba LABS to an approved waste disposal facility will be done by the service provider as specified by the National Environmental Management: Waste Act no. 59 of 2008, Part 5: Storage, Collection and Transportation of Waste, through the use of their own vehicles which will meet with requirements as stated in the above-mentioned act.

Service provider must provide proof of the following:

- 1) List of vehicles and road worthy certification.
- 2) List of drivers and valid driver's licence (PrDP).
- 3) Proof of training if available (eg. First-Aid, Emergency Response, Spill control and cleanup, etc...)
- 4) List of approved Waste Disposal Facilities used.
- 5) Proof of Registration / Certification for Waste Disposal Facility/s

Note that only the iThemba LABS contact persons (RSHEQ Department Staff – This includes Safety and Security Personnel) will be authorised to sign off on services delivered.

FREQUENCY OF COLLECTIONS

Collection of waste skips will be conducted every Wednesday of every week before 12H00. In the event that collection of waste will be delayed or not take place, the service provider is required to notify the iThemba LABS contact person (RSHEQ Department Personnel), providing reason/s for the delay / cancellation and what remedial actions will be implemented to ensure provision of services continue.

CRADLE-TO-GRAVE PRINCIPLE

Once the waste has been disposed of at an approved facility, the Service Provider will be required to provide a waste manifest, delivery note and a safe disposal certificate to prove that a "cradle to grave" process has been followed in accordance with regulatory requirements.

ADDITIONAL SERVICES

iThemba LABS may also request the provision of additional waste skips for the collection and disposal of Building and / or non-compactible waste. The service provider will be required to assist with the provision of suitable skips and the delivery thereof within 3 days of the approval of the provided quotation. Removal of the skips for final disposal at an approved waste management site should also be actioned within 2 days of the request for removal.

The service provider may also be requested to assist with the removal and disposal of hazardous chemical waste on special request. All required information will be provided as and when needed.

INCLUSIONS

Waste to be collected by the Service Provider will be defined as General Waste and will include the following:

- 1) General commercial Waste
- 2) General Industrial Waste
- 3) Building Rubble / Waste

Hazardous Chemical waste pickup will be done upon special request as and when the need arises.

EXCLUSIONS

Sub-contracting of services will not be permitted.

The service will NOT include the following waste streams:

- 1) Biological waste
- 2) Flammable and explosive substances
- 3) Radioactive waste materials

SAFETY, HEALTH AND ENVIRONMENTAL REQUIREMENTS

All activities conducted by the service provider and its personnel must be conducted in terms of the OHSA, NEMA and iThemba LABS Health and Safety requirements, so as to prevent or acceptably control, impacts to the environment and the public.

PRICING SCHEDULE

Pricing for provision of services is as follows:

- 1) Once of cost: Provision, Delivery and Placement of 2 x 6m³ (REL) skips.
- 2) Monthly rental fee for skips.
- 3) Weekly pickup, transport and disposal cost.
- 4) Monthly total cost for provision of services.
- 5) Yearly forecast for price increases over a 5-year period for points 2, 3 and 4
- 6) Costs for supply and delivery of a suitable waste skip for building / non-compactible waste and the removal thereof.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
