As part of destination marketing the municipality wishes to exhibit the diverse tourism products from arts and craft to the hospitality sector in the Tourism Indaba 2025 at the Durban ICC.

2. OBJECTIVE

- To have a dedicated and experienced service provider that knows the tourism industry.
- To promote IHLM as a preferred destination by showcasing various products at the Tourism Indaba 2025 in Durban.
- To have a smooth professional working relationship with the service provider so as to execute the task at hand.
- To exhibit at the Tourism Indaba in Durban.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
