1. BACKGROUND

The Office of the Premier (OTP) seeks to appoint a reputable service provider to provide training and certification on ITIL ® 4 foundation for 12 officials.

2. SCOPE OF WORK

The service provider is expected to deliver the following:

- Conduct training/course through virtual instructor-led sessions on ITIL® 4 Foundation and Certification for twelve (12) officials.
- Provide theoretical tuition and prepare learners for all the required formative modes of learning.
- Facilitation must be pitched in English
- Use of blended online approaches to learning such as digital role-plays, interactive activities, breakout group discussions, and exposure to virtual case studies is mandatory during facilitation.

3. COURSE OUTCOMES

The course will help the candidates to understand:

- How a modern IT and digital service organizations operate
- How value streams increase speed and efficiency
- How cultural or behavioural principles guide work that benefits the wider organization
- How to use commonly used service management terms and concepts
- How to provides a single point of contact for users to report incidents, request services, and get support.
- How to ensure restoration of normal service operation as quickly as possible after an incident occurs.
- How to identify the root causes of incidents and prevent them from recurring.
- How to manage changes to services and infrastructure, ensuring minimal disruption.
- Ensure that agreed-upon service levels are met and maintained.

- Facilitators must have the necessary IT infrastructure, including computers, stable internet connectivity, presentation software, and virtual collaboration tools.
- Training will be conducted virtually through a secure and reliable online platform (e.g., MS Teams, Zoom, or equivalent).

- The service provider must be ITIL certified to provide the ITIL training courses.
