INTRODUCTION TO THE Ithemba LABS BUSINESS UNIT

iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites in the Western Cape and Gauteng respectively, these provide facilities for:

- Basic and Applied Nuclear Physics Research using Particle Beams
- Research Radiation Biophysics
- The supply of Accelerator-produced Radioactive Isotopes for Nuclear Medicine and Research

CONTEXT OF THIS PROCUREMENT NEED

The Nuclear Medicine Department at iThemba LABS manufactures sterile radiopharmaceuticals. The HPLC is used to determine radiochemical purity of the ^{18}F -FDG. Testing of radiochemical purity is a regulatory requirement and forms part of the release criteria of the ^{18}F -FDG product.

PART A – CONTRACT

iThemba LABS seeks to appoint a service provider to supply, deliver and install a High-Performance Liquid Chromatography (HPLC) system for the Nuclear Medicine Department at iThemba LABS.

DETAILED SPECIFICATIONS

High-Performance Liquid Chromatography (HPLC) System

1. System Controller

- Dimensions: W 260 × D 500 × H 72, 5 kg (Approximately)
- The system controller must be able to control up to 8 connectable HPLC modules or units.
- The system controller must be able to accommodate an analog board for converting Radio-HPLC detector's analog signal to a digital signal.
- The system controller must have a built-in web monitor which allows remote real-time monitoring of system status and chromatograms.
- The system controller must have at least 1 event input and 2 event outputs.

2. Solvent Delivery Unit

- Dimensions: W 260 × D 500 × H 140 mm, 10 kg (Approximately)
- All wetted pump parts must be made of polyetheretherketone (PEEK), ruby, sapphire, Perfluoroelastomer, and high molecular weight polyethylene to prevent corrosion and metal-related adsorption.
- The HPLC pump must be able to operate up to a maximum pressure of 300 kg/cm² (30 MPa)
- The HPLC pump must have a flow rate setting range from 0.0001 to 5.000 ml/min.
- The HPLC pump must have a flow rate accuracy of $\pm 2\%$ or $\pm 2 \mu\text{L}/\text{min}$.
- The HPLC pump must have a flow rate precision of $\leq 0.06\%$ RSD or 0.02 min SD.
- The HPLC pump must have a gradient concentration accuracy of $\pm 1.0\%$.
- The HPLC pump must have an available pH range of 1 to 14.
- The HPLC pump must have an automatic pump rinsing kit to automatically clean/flush pump plungers and seals.

3. Degassing Unit

Dimensions W 260 × D 500 × H 72, 4 kg (Approximately)

- The degasser must be able to accommodate 4 mobile phase lines and 1 rinse liquid line.
- All wetted parts of the degasser must be made of PEEK and polytetrafluoroethylene (PTFE) to prevent corrosion and metal-related adsorption.

4. Column Oven

- Dimension W 130 × D 500 × H 553, 15 kg (Approximately)
- The oven must have a temperature control range from Room temperature –10 °C to 85 °C.
- The oven must be able to accommodate at least 3 columns of 300 mm or less in length.
- The oven must have a temperature accuracy of ± 0.8 °C.
- The oven must have a temperature precision of ± 0.1 °C.
- The oven must use forced air circulation and electronic cooling.

5. Autosampler

- Dimension W 260 × D 500 × H 280 (Protrusion adds 140 mm to the depth), 24 kg (Approximately)
- The autosampler must be able to operate at maximum pressure of up to 105 MPa
- The autosampler's sample flow line must be non-metallic or made of PEEK.
- The autosampler's injection volume reproducibility for different injection volumes, must meet the following %RSD requirements:
 - $\text{RSD} \leq 1.0\%$ (0.5 to 0.9 μL),
 - $\text{RSD} \leq 0.5\%$ (1.0 to 1.9 μL),
 - $\text{RSD} \leq 0.25\%$ (2.0 to 4.9 μL),
 - $\text{RSD} \leq 0.15\%$ (More than 5.0 μL).
- The autosampler must have an injection volume accuracy of $\leq \pm 1\%$ (5 μL injection, $n = 20$).
- The autosampler must have an injector linearity of ≥ 0.9999 .
- The autosampler must have a sample cooler temperature setting range of 4 to 45 °C.
- The autosampler must have a sample cooler temperature accuracy of ± 2 °C. The sensor position must be ± 0.5 °C.
- The autosampler must have an available pH range of 1 to 14.
- The autosampler should be able to accommodate a minimum of 100 samples.
- The autosampler must have an % carryover of $\leq 0.0015\%$ (without rinse) and $\leq 0.0003\%$ (with rinse).
- The autosampler must have an injection volume range from 0.01 to 50 μL .

- The autosampler must have a dip rinsing outside the needle, injection port rinsing, and a pumping rinse outside the needle and internal rinsing as part of the equipment.

6. Differential Refractive Index Detector

- Dimensions: W 260 x D 420 x H 140, 12 kg (Approximately)
- The Refractive Index detector must have a measurement range from 1 to 1.75 RIU.
- The Refractive Index detector must have a detector drift of $\leq 1 \times 10^{-7}$ RIU/h.
- The Refractive Index detector must have detector noise of $\leq 2.5 \times 10^{-9}$ RIU.
- The Refractive Index detector must have a measuring range of at least 0.01×10^{-6} to 500×10^{-6} RIU (Analytical mode) and 1×10^{-6} to 5000×10^{-6} RIU (Preparative mode, Large-prep mode).
- The Refractive Index detector must have a cell temperature control range from 30 to 60°C.
- The Refractive Index detector must have a cell volume of 9 µl and a maximum pressure of 2MPa
- The Refractive Index detector must have a maximum sampling rate of 50 Hz
- The Refractive Index detector must have an operating temperature of 4 to 35°C.
- The Refractive Index detector must have zero adjustment, Auto zero, Optical zero, and Fine zero

7. Radio-HPLC detector system

- Dimensions (without detector) 70 (h) x 160 (l) x 150 (w), all mm, 2.0 kg (Approximately)
- The Radio-HPLC detector must be compatible with the specifications of other components in this bid document.
- System must have Smart detector technology (or similar) with all optimised detector operating voltage parameters and optimised detector discrimination window parameters stored in the detector memory.
- System must have a background count rate of <10 cps.
- System must have a count rate up to 2,500,000 cps, a Linearity range from 0 - 1,000,000 cps and a Coefficient of determination $r^2 \geq 0.99$
- System must have 2 configurable I/O (Input/Output) lines, 0-5 V.
- System must have an analogue output of 0 to 3 V, scalable as counts/mV, where users can take the analogue signal into any third-party software.
- System must use a Silicon Photomultiplier (SiPM) plastic scintillator detector suitable for measuring ^{18}F -FDG.
- Detector must use Peltier temperature control to ensure stable operating temperatures to deliver consistent detector performance.
- Detector must have a temperature control range of 10 to 40°C.

- Detector must be cableless and automatically detected by the system and their operating parameters automatically retrieve from software, ensuring Good Laboratory Practice compliance.
- The detector unit must have bespoke lead shielding to minimise background interference.
- System must have LAN/USB connectivity to computer system.
- Detector system should have an LED system status indicator for quick identification of operational mode or error state.

8. **HPLC Software Specifications**

- The HPLC system and software must include automated support functions utilizing digital technology, such as M2M (Machine-to-machine), IoT (Internet of Things), and Artificial Intelligence (AI), that enable higher productivity and maximum reliability.
- The HPLC system and software's Artificial Intelligence (AI) functions must allow a system to monitor and diagnose itself, handle any issues during data acquisition without user input.
- The HPLC system and software must support the acquisition of high quality, reproducible data regardless of an operator's skill level for both routine and demanding applications.
- The HPLC chromatographic data system software must be fully GMP compliant and meet all data integrity requirements.
- The HPLC System software must be compliant with ER/ES (Electronic Records and Electronic Signatures) regulations.
- The HPLC System software must provide safe and secure data management by managing the data securely within a database, thereby preventing overwriting, and deletion of data.
- The HPLC System software must include the ability to overlay chromatographs, label peaks, enlarge chromatograph features, and thus provide various ways of viewing the chromatography data.
- The HPLC System result repository must be searchable for the specific laboratory results.
- The system must use authority checks to ensure that only authorized individuals can utilize the computer system.
- The HPLC System software must be able to store and recall sample processing settings.
- The system must provide a means to archive, retrieve and print accurate, complete and human readable copies of GMP electronic records along with any applicable GMP audit trails and GMP electronic signatures for the retention period.
- The system must have an audit trail to record actions that create, modify, or delete GMP electronic records including:

- Type of action
- Identity of the operator that performed the action
- Date and time of action
- Previous value and new value
- Reason for change
- The system must provide a means to unambiguously link dynamic GMP electronic records with associated audit trails.
- The HPLC System must be capable of the following sample processing features:
 - Baseline detection and drift
 - Noise detection
 - Plate count detection
 - Peak detection threshold
 - Peak time, height, width, area, percentage area, resolution, and tailing determinations.
 - Peak identification and labelling
 - Peak tables
 - Calculating calibration correlation coefficient

2. Onsite Qualification and Calibration after installation for a period of 5 year

- Service level is within 10 minutes from the time of logging the call.

MANDATORY QUALIFICATION TO EXECUTE THE CONTRACT

1. **Technical: The bidder provides the following as proof of being able to execute the contract to the contract terms:**
 - 1.1. The bidders must provide datasheets for the whole HPLC system (including the radio detector and Software) mentioned in the bid specifications.
 - 1.2. Bidders must be authorised distributor or exclusive supplier for the HPLC system. Proof (signed and dated letter from the Manufacturer must be provided).
 - 1.3. Minimum of three (3) contactable references where the bidder has supplied, installed and carried out training for HPLC systems, with contact details (telephone number and email address) of the client.
 - 1.4. Training certificates (from manufacturer) of the installer and trainer must be provided.

CONTRACT PERIOD

Five (5) years service contract (commences from the date of fully signed SBD 7.1) with option to renew for five (5) years. (Based on performance).

SPECIAL CONDITIONS OF CONTRACT MANAGEMENT

Project Management

The Nuclear Medicine department of iThemba Labs Cape Town is responsible for this Tender and subsequent contract. Contact details provided to the appointed service provider's Key Account Manager.

Implementation, hand over, and product management

The appointed bidder provides the delivery management as specified in the detailed specification on page **Error! Bookmark not defined.** and on page 9 for installation and ongoing support. iThemba LABS will issue written purchase orders as a project control tool for each requirement under this contract

Incidental Services and Spares to the subject matter of this contract (General Condition of Contract Clause No: 13 and 14)

In the event of requiring such incidental services and/or spares, it is only valid for payment when issued written purchase order that specifies, where applicable, quality, quantity, description, unit price, and delivery date.

Performance Verification (General Condition of Contract Clause No: 8)

The iThemba LABS appointed project manager verifies the performance of this contract with reference to the required requirements and any other element specified in this contract:

1. The appointed bidder deliver equipment including spares, upgrades meeting the specifications under this contract.
2. The appointed bidder provides services to the specification level set in this contract.
3. All performances are verified by the iThemba LABS appointed project manager.
4. Both parties signed off on performance on the verification documentation
5. Both parties agree on quantity, unit cost, and total value on the same signed document.

Contract Due Diligence during the contract period

iThemba LABS has the right to conduct supply chain due diligence. The iThemba LABS Project Team have the right to conduct site visits and inspections at any given time during the contract period.

Communication (General Condition of Contract Clause No: 31)

The appointed bidder communicates in writing through regular mail, physical delivery, or email. The appointed bidder states the contract number and purchase order number on communication documentation. The contract bidder does not act upon any communication without the contract number or must verify such communication with the iThemba LABS project manager prior to acting upon it.

Performance Security (General Condition of Contract Clause No: 7)

1. Advance payment security:

An acceptable financial performance bond is required where iThemba LABS pays an upfront deposit in excess of R 1 million to the same value as any such upfront deposit.

2. Performance security:

No other performance security is required.

Packing (General Condition of Contract Clause No: 9)

Components (where applicable) must be packaged such that they prevent damage during transportation and storage.

Delivery and Documentation (General Condition of Contract Clause No: 10)

Refer to paragraph 10 of bid specification.

Payment (General Condition of Contract Clause No: 16)

Payment terms are within 30 days of receipt of an invoice issued following successful rendering of services and earlier where the invoices are accompanied by signed iThemba LABS delivery validation documents including proof of performance stating acceptance of quantity, acceptance to specification, and unit pricing in agreement with the contract and any purchase orders issued in terms of the contract. The supplying party's invoices must meet the following minimum requirements:

1. Reference the purchase order number
2. Detailed line items as specified in purchase order
3. Include statement of account
4. Include detailed line items as specified in purchase order

It is in the interests of the appointed bidder to adhere to these to receive prompt payment. Any losses incurred through exchange rate variations or interest charged on late payment will be charged to the appointed bidder where these costs arose from non-adherence to the above.

Warranty (General Condition of Contract Clause No: 15)

1. The warranty periods set out in GCC15.2 are 12months.

PERFORMANCE LEVEL (General Condition of Contract Clause No: 22)

a) Service Management

- a. The service performance levels are stated in Performance Levels Statement
- b. The NRF measures the contracted bidder's performance against these in the execution of the contract.
- c. The contracted parties recognize that its failure to meet the performance levels has material adverse impact on the operations of NRF and that the damage from the contracted bidder's failure to meet any performance level is not susceptible to precise determination.

b) If the appointed bidder fails to meet any performance level:

- a. Both iThemba LABS and the appointed bidder shall jointly investigate and report on the root causes of the performance level failure;
- b. Promptly correct the failure and begin meeting the set performance levels;
- c. Advise iThemba LABS as to the extent requested by iThemba LABS of the status of remedial efforts being undertaken with respect to such performance level failure; and
- d. Take preventive measures to prevent the recurrence of the performance level failure.
- e. In the event of the non-performance as per the agreed contract, iThemba LABS will appoint an alternative provider at the cost of the appointed bidder. The defaulting appointed bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.

c) Termination for Default (General Condition of Contract Clause No: 23)

In the event of the non-performance as per the agreed contract, iThemba LABS will appoint an alternative provider at the cost of the appointed bidder. The defaulting appointed bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.
