- 1.1 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.2 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income -generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

SPECIAL REQUIREMENTS

1. Compulsory briefing/ site inspection.
2. A valid tax compliance status pin document, Valid B-BBEE or Sworn Affidavit, Completed SBD 4 and 6.1.
3. One reference letter of similar work performed not older than six (06) months.
4. A valid CIDB registration of **2GB or higher** must be submitted with the bid.
5. The bidder shall inspect the site before submitting a quotation to verify all dimensions, quantities, and existing site conditions.
6. All measurements shall be verified on site before manufacturing, ordering, or installing any materials. Dimensions provided by the Institute are for guidance only.
7. All materials supplied shall be new, free from defects, of good quality, and compliant with the relevant South African National Standards (SANS), National Building Regulations, and manufacturer's specifications.
8. The successful bidder shall provide all labour, supervision, tools, equipment, transport, lifting equipment, consumables, and any other resources necessary to complete the works.
9. The contractor shall supply and install all windows, tiles, partitions, and signage in accordance with recognised industry best practices and the manufacturer's installation guidelines.
10. Existing finishes, fittings, furniture, equipment, and building components shall be adequately protected during the execution of the works. Any damage caused by the contractor shall be repaired or replaced at the contractor's own cost.
11. Where existing windows, tiles, partitions, or signage are removed, all demolition materials, rubble, and waste shall be removed from site and disposed of at an approved waste disposal facility.
12. The contractor shall maintain a clean, safe, and orderly work environment throughout the duration of the project and shall clean the work area daily and upon completion.

13. The contractor shall comply with the Occupational Health and Safety Act, 1993 (Act 85 of 1993), including all applicable regulations.
14. All installed windows, partitions, tiles, and signage shall be level, plumb, securely fixed, properly aligned, neatly finished, and free from visible defects or damage.
15. The contractor shall minimise disruption to the Institute's operations and shall perform noisy or disruptive work only during times approved by the Institutes representative.
16. Upon completion, the contractor shall make good all disturbed areas, including plastering, painting, sealing, and finishing where installation work has affected existing building surfaces.
17. The quoted price shall include the complete supply, delivery, installation, testing (where applicable), commissioning (where applicable), final cleaning, and handover of all works.
18. The successful bidder shall provide a minimum 12-month warranty on workmanship and installation from the date of practical completion. Manufacturer warranties for all supplied materials shall also be provided where applicable.
19. Payment shall only be made after the works have been inspected, accepted, and certified as complete by the Department's authorised representative.
