Formal tenders sealed and individually clearly marked “with the tender number and description of choice as detailed above” must be placed in the Municipal tender box, **26 Church Street, OUDTSHOORN (Corner of Church and St. George’s Street, entrance at St. George’s)** no later than **12h00 on FRIDAY, 16 FEBRUARY 2023** and will be opened in public immediately thereafter at the **Supply Chain Management Office, OUDTSHOORN** or any alternative place in Oudtshoorn Municipal Offices

A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of **120 days** after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R361.00 including VAT** for hard copies directly printed by the Municipality and **free of charge when provided on pdf via e-mail**. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and / or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

***Escalation effective from month 13 – the bidder will be allowed to escalate prices on an annual basis in line with CPIX**

The above formal tender will be evaluated and adjudicated in terms of the **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2022), and Oudtshoorn Municipality’s Supply Chain Management Policy.
