- A submission submitted in response to this RFB will constitute a binding offer which will remain binding and irrevocable for a period of **one hundred and twenty (120) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFB validity period is still in force. **(RFB Validity Period: 120 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFB.
- Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.

INTRODUCTION TO MHSC

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research.

In the 2024/25 financial year, the MHSC established a panel of technical experts through an open competitive tender process. Following implementation of the panel, it was identified that additional technical expertise is required to strengthen capacity, improve turnaround times and ensure broader technical coverage.

This process therefore seeks to supplement and expand the existing panel and does not replace or terminate the currently appointed service providers.

Note: Current technical experts do not need to resubmit bids, as they already serve on the panel. However, if they wish to bid for other thrust areas, they may do so.
