Interested bidders must attach proof of the following documents to avoid disqualification:

Certified copy of valid BBBEE Certificate or Sworn Affidavit of BBBEE status level; Copy of company registration certificate/ documents from CIPC; Certified ID copies of all director; Copy/ printed Tax compliance status Pin or certificate; Copy of current municipal account (not older than 3 months) or copy of Lease Agreement and proof of payment for lease not older than 3 months ; Certified copies of Permission to Occupy (PTO's) land for bidders residing in Tribal Authority's areas of jurisdiction; CSD registration summary report (ideally not older than 3 months); Joint Venture Agreement (In case of a Joint Venture); initial every page of the bid document; all

MBD forms be completed in full. Proof of professional registration with Property Valuation Profession ACT No. 47; signed joint venture agreements in case of a joint venture companies, initial every page of the bid document.

Closing Time of Bids

The closing time for submission of bids is **12.00 pm on Thursday, 29 of September 2022**. Bids. Telephonic, facsimile, e-mail and late bids will not be accepted. Bids must remain valid for a period of ninety (90) days after the closing date of the bid. Renosterberg reserves the right to extend the validity period, should you not be willing to hold your bid valid in all respects for a further period as requested, it will lapse on expire of the current validity period.

EVALUATION OF BIDS

N.B: Functionality criteria

The evaluation of this bid will be subjected to Functionality scoring as follows:

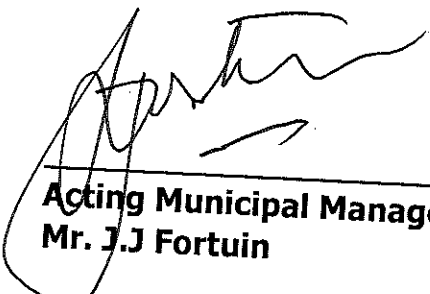
Quality Criteria	Evaluation Schedule	Maximum number of points
Experience of the tenderer	Schedule 1 as per bid document	40
Experience of key personnel	Schedule 2 as per bid document	40
Approach paper (methodology)	Schedule 3 as per bid document	20
Maximum possible score for quality (Ms)		100

The Tenderer must comply with the minimum requirements in accordance with the Functionality Criteria table above and must obtain at **least 70 points** under the Points Allocation of the Functionality Criteria to qualify.

Bidders shall take note of the following bid conditions:

- a) Renosterberg Local Municipality Supply Chain Management Policy will apply on this bid;
- b) Broad Based Black Economic Empowerment (B-BBEE) Act will apply on this bid;
- c) Renosterberg Local Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or part of the bid;
- d) The municipality reserves the right to negotiate further conditions with the successful bidder;
- e) The municipality reserves the right not to appoint;
- f) No bidder will be appointed if not registered on Central Supplier Database;
- g) Contract period of this bid is 3 years **(1 October 2022 – 30 September 2025)**.
- h) Late, incomplete, unsigned, faxed or emailed bids will not be accepted.

The Municipality reserves the right to withdraw any invitation to bid and/or re-advertise or to reject any bid or to accept a part of it. The Municipality does not bind itself to accept the lowest bid or to award a contract to the Bidder scoring the highest number of points.
