Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system. The Transnet e-Tender Submission Portal can be accessed as follows: - Log on to the Transnet eTenders management platform website/Portal using Google Chrome: transnetetenders.azurewebsites.net; - Click on "ADVERTISED TENDERS" to view advertised tenders; - Click on "SIGN IN/REGISTER to register new bidder information and ensure that all mandatory information is completed OR to sign in if already registered; - Toggle (click to switch) the "Log an Intent" button to submit a bid; Respondents are to submit bid documents by uploading them onto the Transnet system against each tender selected. A Bidder can upload 30mb per upload and multiple uploads are permitted. - Bidders should ensure that electronic bid submissions are submitted at least a day before the closing date and bidders should not wait for the last hour before the deadline to submit. This is to enable them to timeously address issues which they may encounter due to internet speed, bandwidth or the size of the number of uploads being submitted. Transnet will not be held liable for any challenges experienced by bidders as a result of their own technical challenges. - No late submissions will be accepted. - Each company must register its own profile using its company details and use the corresponding registered profile to log an intent to bid as well as submitting any bid. Transnet will not accept a bid or will disqualify a bidder who submits a bid in the Transnet e-tender submission through another bidders'/Company's profile. 1 Responses to RFQ

Responses to this RFQ [**Quotations**] must not include documents or reference relating to any other quotation or proposal. Any additional conditions that the bidder wants to bring to the attention of Transnet must be embodied in an accompanying letter.

2 Formal Briefing

A formal briefing session will not be held but should Respondents have specific queries they should email these to the Transnet employee(s) indicated in paragraph 3 [*Communication*] below:

2.1 Bidders are required to confirm their attendance and to send their contact details including the number of representatives (where applicable) to the following address sipho.ndlovu@transnet.net. This is to ensure that Transnet may make the necessary arrangements for the briefing session.

3 Communication (Clarifications and Complaints)

3.1 Specific clarification queries relating to this RFQ before the closing date of the RFQ should be submitted to [**Sipho Ndlovu**] before **15 H 00 on 03 DECEMBER 2025**. In the interest of fairness and transparency Transnet's response to such a query will then be made available to other bidders.

3.2 Specific complaints relating to this RFQ before or after the closing date should be formally submitted by emailing groupscmcomplaints@transnet.net. Once the complaint has been submitted, the Transnet SCM Complaints office will acknowledge your complaint and send you a complaint form for completion.

3.3 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFQ between the closing date and the date of the award of the business.

3.4 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

3.5 The outcome of the process will be communicated, via email, to all bidders as soon as the process is concluded. Should a bidder not receive any communication from Transnet 30 days after the expiry of the validity period of this bid, the bidder can consider its bid not being successful. All unsuccessful bidders have a right to request Transnet to furnish reasons for their bid not being successful. This requested must be directed to the contact person stated in the SBD 1 form

4 Legal Compliance

The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

5 Employment Equity Act

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

6 Changes to Quotations

Changes by the Respondent to its submission will not be considered after the closing date and time.

7 Binding Offer

Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

8 Disclaimers

8.1 Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that Transnet reserves the right to:

- modify the RFQ's goods / service(s);
- award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;
- split the award of the order/s between more than one Supplier/Service Provider as may be explicitly articulated in the conditions or objective criteria to this RFQ;
- cancel the quotation process;
- validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- request audited financial statements or other documentation for the purposes of a due diligence exercise;
- not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provides for it;
- to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;

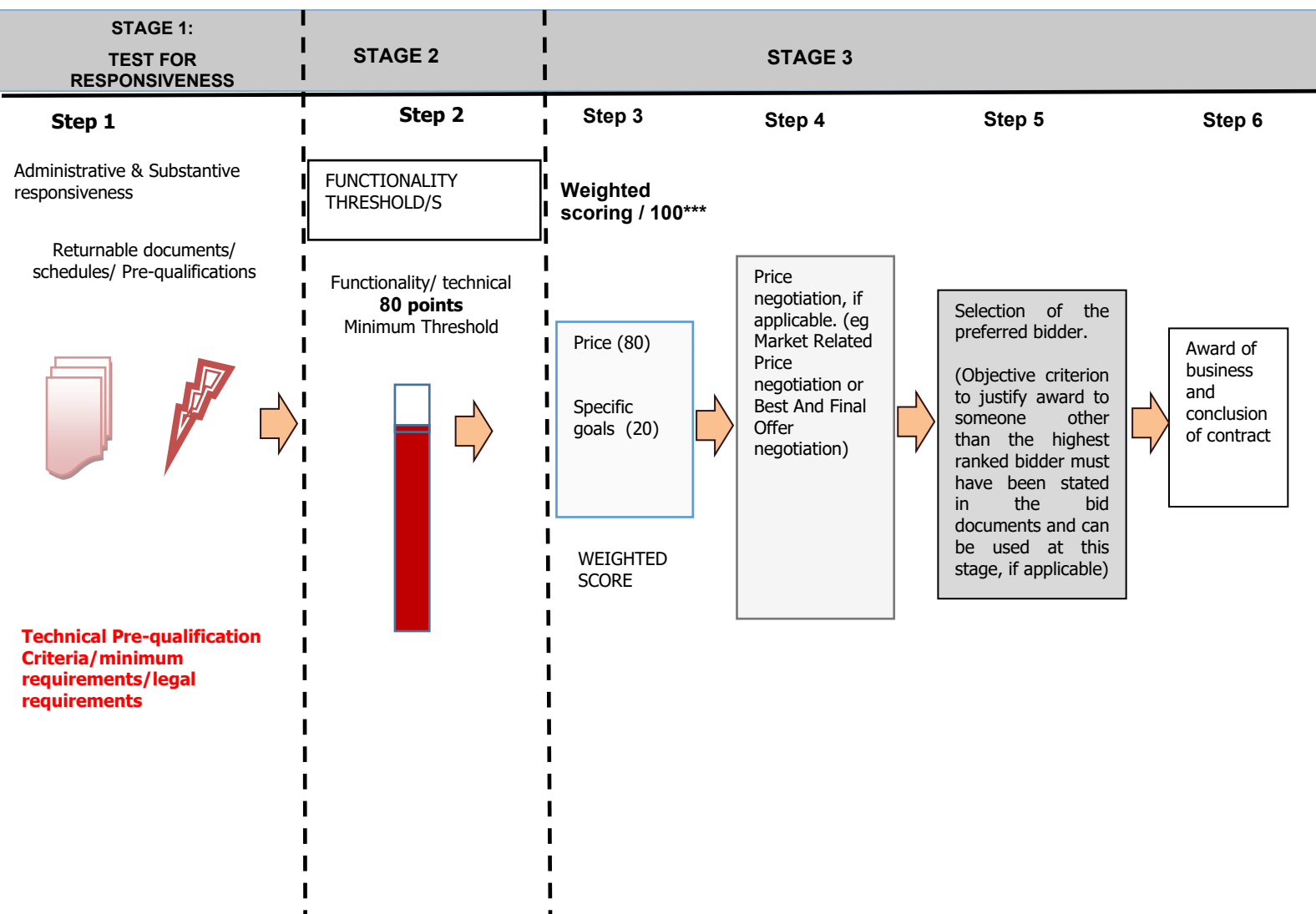

Respondents are to note that Transnet will round off final technical scores to the nearest 2 (two) decimal places for the purposes of determining whether the technical threshold has been met.

1.2 **STEP FOUR: Price Negotiations (if applicable)**

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
 - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
 - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

1.3 **STEP FIVE: Objective Criteria (if applicable)**

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- Skills Transfer and Capacity Building for Transnet;

- Impact on Transnet's Return On Investment;
- Rotation of Suppliers to promote opportunities for other suppliers, by overlooking a supplier that has been awarded business repeatedly overtime, in the same commodity, in order to benefit other suppliers in the market;
- the bidder is undergoing a process of being restricted by Transnet or other state institution that Transnet may be aware of,
- the bidder is insolvent, in receivership, under Business Rescue as provided for in chapter 6 of the Companies Act, 2008, bankrupt or being wound up, has his affairs administered by a court or a judicial officer, has suspended his business activities, or is subject to legal proceedings in respect of any of the foregoing,
- the bidder is unable, as objectively determined by Transnet, to perform the contract free of conflicts of interest.
- all risks identified during a risk assessment exercise/probity check (which may be conducted by an authorised third party) that would be done to assess all risks, including but not limited to:
 - the financial stability of the bidder based on key ratio analysis, which would include, but not be limited to Efficiency, Profitability, Financial Risk, Liquidity, Acid Test, and Solvency;
 - a commercial relationship with a Domestic Prominent Influential Person (DPIP) or Foreign Prominent Public Official (FPPO) or an entity of which such person or official is the beneficial owner; and
 - reputational and brand risks.

1.4 STEP SIX: Award of business and conclusion of contract

- Immediately after approval to award the contract has been received, the successful or preferred bidder(s) will be informed of the acceptance of his/their Quotation by way of a Letter of Award. Thereafter the final contract will be concluded with the successful Respondent(s), where applicable.
- Alternatively, the acceptance of a letter of award by the Successful Respondent will constitute the final contract read together with their RFQ response and the Standard Terms and Conditions. This will be stated in the letter of award.

2 Validity Period

Transnet requires a validity period of 180 [One hundred and eight] Business Days from the closing date of this RFQ, excluding the first day and including the last day.

Bidders are to note that they may be requested to extend the validity period of their bid, on the same terms and conditions, if the internal evaluation process has not been finalised within the validity period. However, once the adjudication body has approved the process and award of the business to the successful bidder(s), the validity of the successful bidder(s)' bid will be deemed to remain valid until a final contract has been concluded.

3 Disclosure of contract information

1. OVERVIEW

The purpose of this scope of work is to engage services for the once off maintenance and testing of electrical network in Pier 1 including the main circuit breakers, transformers, and related equipment, on all the RMGs and STS cranes at Transnet Pier 1, Durban Container Terminal. The Medium Voltage network within the Durban container terminal Pier 1 is made up of 2x 11kV substations namely Quayside substation and Pier 1 reefer substation. The Quayside substation feeds 11Kv to seven STS cranes and two RMGs.

2. EMPLOYER'S OBJECTIVE

The employer's objective for this project is to implement a once off maintenance for the RMGs and STS cranes. The crane equipment consists of but is not limited to transformers, fuses, busbars, voltmeter, ammeter, circuit breaker and slip rings

3. SCOPE OF WORK

The following should be carried out. The maintenance should include (but not be limited to) the listed items below:

3.2. STS AND RMG Cranes

- Transformer visual check
- CB operating mechanism & test trip CB's.
- Bushings visual check (where applicable).
- Visual checks of all main earth connections.
- Clean Transformers
- Maintain slip rings
- All panel wiring/cubicles check & clean.

3.3. HT Switchgear

- The appointed contractor is to conduct maintenance and testing on all HT circuit breakers, link switches, incomers and feeders.

- The contractor ensures the correct operation of the switchgear units, ancillary apparatus, and electrical tripping mechanism before it returns to service.

3.4. Distribution Transformers (Dry Type)

- Cleaning and torquing of transformer bushings, terminals. Torquing of all loose bolts with impact wrench. Megger test the transformer windings and record all values. Perform induced over voltage, winding resistance, ratio, vector group verification, transformer losses, partial discharge tests, and Tan Delta testing for dryness of winding and bushing. Check and record transformer tap changer settings, etc.
- As an addition to the above, look for rust on the clamps and core steel, carbonization or tracking on the windings and insulation. Check for discoloration on surfaces, and loose connections. Clean the transformer, preferably using a vacuum. Tighten any hardware components that appear to be loose.

3.5. Busbars and Busbar chamber

- Visual inspect for corrosion, discoloration, cracks, loose joints
- Clean bus bar using dry cloth, brush or vacuum
- Re-torque all bolted joints to OEMs specifications
- Replace damaged bolts, washers or spring washers
- Conduct insulation resistance (Megger) tests between phases and to earth.
- Perform continuity checks to ensure proper connections.
- Measure contact resistance across joints to detect high-resistance points

3.7 Earthing

- Inspect for the continuity of all earthing connections and ensure that the system is grounded as required. Test the resistance to ground of the earth connection and record the values for all test points.

3.8 Transformer Rooms

- Sweep and wipe all transformer internal floors and walls.

- Replace all ventilation filters.
- Clean, lubricate and repair all transformer doors.
- Clean and remove foreign objects in cable trenches (Dust affects smoke detectors installed in cable trenches).

3.9. 11kV Slip ring Panels and Junction Panels

- Slip ring panels and 11kV junction panels are to be inspected, cleaned and maintained. Insulation testing is to be done upon completion of the cleaning at the correct test voltage. Any failed components or components showing potential failure are to be identified and communicated with Transnet.

3.10. Circuit Breaker Testing: (11KV & 630 V)

- Conduct speed testing to check the operating speed of the circuit breakers.
- Perform ductile tests.
- Test closing/opening coils to ensure proper switching operations.
- Perform spring charger motor testing.
- Conduct mechanical movement testing.
- Perform vacuum bottle testing (only applicable for 11kV vacuum breakers).

3.11. Conducting the work

- Work is to be done on site and any work that is required off-site will be to the service providers cost and should be communicated timeously with TPT.
- Work should be planned in a manner to avoid any disruptions to operations and in event of disruptions communication should be made timeously with TPT representatives.
- Once commenced work should be conducted during weekdays, weekends and public holidays. No breaks should be taken for any of the above to minimise outage time.

NB: All engineering work done within Transnet substations should be under the supervision of an A-Brown approved Transnet employee where relevant work and safety permits have been issued.
