- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

TERMS OF REFERENCE (TOR)

Provision of Terrain Maintenance and Gardening Services for Onderstepoort Biological Products (SOC) Ltd

1. Background

Onderstepoort Biological Products (SOC) Ltd (OBP) is a Schedule 3B National Public Entity responsible for the development, manufacture, and distribution of animal vaccines to support animal health and food security.

2. Purpose

OBP intends to appoint an experienced and financially stable service provider to deliver comprehensive terrain maintenance, landscaping, and gardening services across its facilities.

3. Scope of Services

The service provider will be responsible for maintaining:

- OBP Main Site, including perimeter fence areas.
- OBP Residential Houses and surrounding areas.
- Experimental Animal Facilities, including stables and paddocks.
- Stormwater drainage systems, channels, and inlets.
- Roads, paved areas, parking areas, lawns, flowerbeds, and veld grass areas.

4. Key Responsibilities

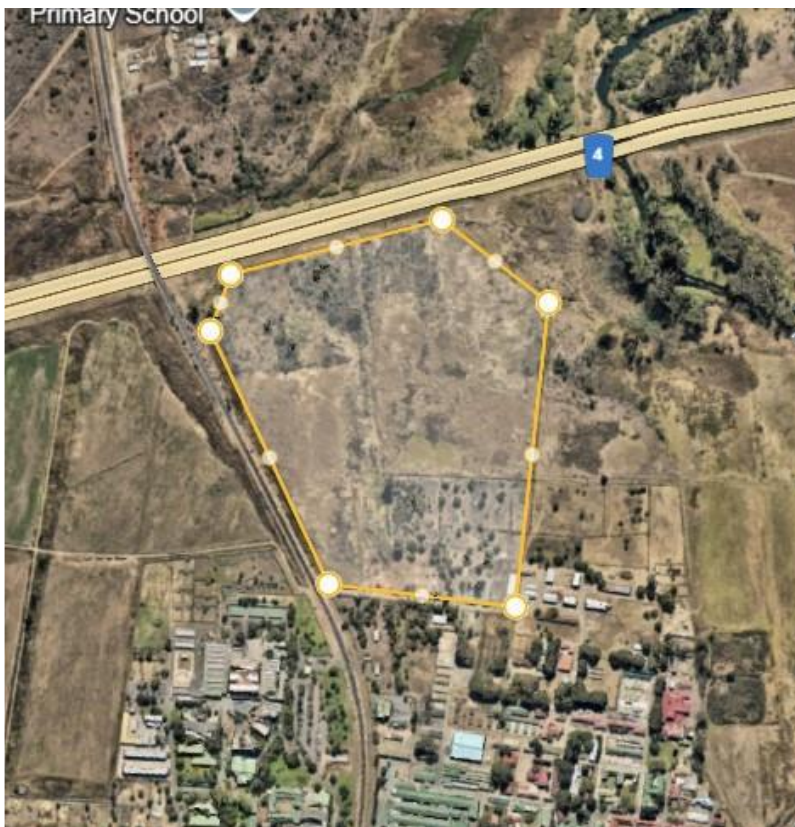
The service provider shall:

- Provide a minimum of eight (8) gardeners and one (1) onsite supervisor daily.
- Maintain approximately 364,574 m² of grounds and landscaped areas.
- De-bushing of Agricultural land estimated 310577 m², inclusive of trees in the designated area
- Mow lawns, trim edges, and maintain veld grass on a weekly basis.
- Remove weeds from fence lines, paved surfaces, and landscaped areas.
- Maintain flowerbeds, shrubs, hedges, and trees.
- Keep paved areas, roads, parking lots, drains, and gutters clean and free of debris.
- Maintain fire breakers twice annually by means of a Motor Grader.
- Fire breaker in the inside of the OBP fence and OBP owned houses (3021m X 6m X 0,1m) up to topsoil
- Remove and legally dispose of all gardening waste on the same day it is generated.
- Ensure stable and paddock areas remain weed-free without the use of herbicides.

5. Equipment and Consumables

The service provider shall supply and maintain all equipment, tools, consumables, and PPE required for service delivery, including:

- Ride-on and petrol lawnmowers
- Brush cutters
- Leaf blowers
- Chainsaws
- Tractor and slasher
- Gardening hand tools
- Herbicides, pesticides, fertilizers, and seasonal plants
- Generator for electrical equipment where required
- Motor Grader for firebreak maintenance

The service provider shall ensure equipment is maintained and replace any faulty equipment within 24 hours.

6. Service Standards

The service provider must:

- Maintain a clean, safe, and aesthetically pleasing environment.
- Ensure continuous service delivery throughout the contract period.
- Have sufficient financial and operational capacity to support uninterrupted service provision.
- Comply with all health, safety, and environmental requirements.
