The eMadlangeni Local Municipality hereby invites reputable contractors to submit proposals/tenders for the above-mentioned project strictly from the appointed panel of contractors of **MN09/2023-24: A PANEL OF SERVICE PROVIDERS FOR THE CONSTRUCTION OF CIVIL ENGINEERING INFRASTRUCTURE PROJECTS (CE and GB) FOR EMADLANGENI LOCAL MUNICIPALITY FOR A PERIOD OF THREE (3) YEARS**). Note that the contractors will be randomly selected from the panel and will receive emails inviting them to bid for the abovementioned tender. Only bidders that receive an email will be eligible to bid for this tender.

Compulsory Briefing Session will be held on Wednesday 23 April 2025 at 10h00 at the Emadlangeni Municipality Town Hall No. 60 Voor Street in Utrecht (CBD) then proceed to the site.

This tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality in which only bidders who score a minimum of 80% will advance to Stage 2 which will be based on the 80/20 Preferential Point System of the Preferential Procurement Framework Act Regulations 2000, (Act No. 5 of 2000) and the amended PPPFA regulation 2022, whereby 80 for price and 20 for specific goals.

The physical address for collection of tender documents is Emadlangeni Municipality, 34 Voor Street, Utrecht. Upon presentation of receipt proving prior payment of non- refundable fee of **R 1 000.00** (Inclusive of VAT) having been made at the municipal Finance Department (Only Cash Accepted) Tender documents will be available as from 08H00 on **16 April 2025 to 23 April 2025 until 10:00.**

Each tender shall be placed in sealed envelopes, endorsed with the MN11/2024-25 and Construction of Luthilunye Access Road in Ward 1, and be placed in the Tender Box at the Municipal Offices, 34 Voor Street, Utrecht, 2980 not later than **12h00 on 02 May 2025** at which the tenders will be opened in public. Tenders are also to be submitted on the tender documentation provided by Municipality.

No correspondence will be entered into with any tender regarding scores obtained, reasons for no appointment, etc. **No late, telephonic, facsimile or e-mailed tenders will be accepted.**

The following tenderers who are registered with the CIDB, or are capable of being so registered prior to the evaluation of submissions are eligible to submit tenders:

- Contractors who have a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered for **5CE** class of construction work; and
- Joint ventures are eligible to submit tenders provided that:

1. every member of the joint venture is registered with the CIDB;
2. the lead partner has a contractor grading designation in the **5CE** class of construction work; and
3. the combined contractor grading designation calculated in accordance with the construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for an **5CE** class of construction work.
