Design, Supply, Installation, Testing and Commissioning of an Automatic Fire Suppression System for a Telemetry RTU Room

1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to solicit quotations from suitably qualified and certified fire suppression system integrators for the design, supply, installation, testing commissioning, certification and handover of an automatic fire suppression system for a dedicated electronic equipment room.

The proposed system shall be specifically designed to protect critical ICT infrastructure including Telemetry master station, computer servers, networking equipment, associated electronics and supporting infrastructure while minimizing damage to equipment during fire suppression activities.

2. BACKGROUND

The protected area is a dedicated RTU room used for housing electronic equipment. The room is generally unoccupied and is accessed only when required for maintenance upgrades backups inspections or fault-finding activities.

The room has the following characteristics:

- Approximate room dimensions
 - Length: 4 m
 - Width: 3 m
 - Height: 3 m
- Total approximate volume: 36 m³
- Drywall construction
- Heat-resistant glazed access doors
- Suspended ceiling
- Air-conditioned environment
- Electronic telemetry server and networking equipment installed within the room
- Access-controlled entry
- Restricted occupancy with no permanent personnel stationed within the room

3. SCOPE OF WORK

The successful bidder shall provide a complete turnkey solution including but not limited to:

3.1 Design

- Conduct a site survey and risk assessment
- Verify room dimensions and enclosure integrity
- Determine the most appropriate automatic clean-agent fire suppression solution

- Design the system in accordance with applicable South African standards manufacturer requirements and regulatory requirements
- Provide detailed design calculations
- Determine agent concentration requirements and discharge characteristics
- Verify room hold times and enclosure requirements
- Provide hydraulic flow calculations pipe sizing calculations nozzle calculations agent quantity calculations and concentration calculations signed by a competent fire suppression design professional
- Verify enclosure integrity and confirm compliance with extinguishing concentration retention requirements
- Determine requirements for pressure relief venting
- Assess air-conditioning shutdown interfaces and any required control interlocks
- Indicate whether an aspirating smoke detection system is recommended for the environment

3.2 Supply

Provide all equipment necessary for a complete operational system including:

- Clean-agent fire suppression cylinders
- Agent storage and discharge hardware
- Release control panel
- Addressable (unique electronic address of each device) smoke detection devices
- Manual release stations
- Abort stations
- Audible and visual warning devices
- Countdown discharge indicators
- Pressure relief vent if required
- Pipework fittings nozzles and brackets
- Signage and safety notices
- Interface modules
- Monitoring and fault indication equipment
- All cabling and termination accessories
- Standby batteries in accordance with SANS requirements
- Detector bases and associated accessories
- The bidder shall propose the most appropriate approved clean-agent extinguishing medium and shall indicate environmental considerations future availability of the proposed agent refill arrangements within South Africa and lifecycle support.
- The bidder shall recommend the most suitable system based on room characteristics applicable legislation environmental considerations and long-term support availability.

3.3 Installation

- Install all suppression equipment and associated infrastructure
- Install addressable cross-zoned detection
- Install double-knock fire detection functionality
- Provide a minimum of two independent fire detection zones
- Automatic release shall only occur following confirmed alarm from both detection zones

- Interface fire suppression system with existing fire alarm systems if available
- Interface with air-conditioning shutdown controls
- Interface with dampers where applicable
- Provide automatic release functionality
- Provide manual release functionality
- Provide abort functionality
- Install warning signage at all entrances
- Install all electrical and control cabling
- Install monitoring and fault indication functionality
- Provide segregation and protection of all installed services

4. TECHNICAL REQUIREMENTS

The system shall:

- Be suitable for protection of electronic equipment, servers, telemetry equipment and networking infrastructure
- Utilise a clean-agent extinguishing medium that will not damage electronic equipment
- Provide automatic fire detection and suppression
- Incorporate cross-zoned detection / double-knock detection logic
- Include pre-discharge alarms
- Include countdown and warning indicators
- Include emergency manual release
- Include emergency abort functionality
- Interface with room air-conditioning systems to prevent loss of extinguishing agent concentration
- Be designed to maintain the required extinguishing concentration for the prescribed hold time
- Include battery backup in accordance with SANS 10139 requirements
- Provide continuous monitoring of system health and fault conditions
- Generate visible and audible fault indications for power failures low agent pressure wiring faults communication failures detector faults isolations and system malfunctions
- Provide a configurable pre-discharge delay of not less than 30 seconds
- Be approved and listed for the intended application

5. FIRE SUPPRESSION OPERATING SEQUENCE

Upon confirmed fire detection and prior to extinguishing agent discharge the system shall automatically:

- Activate audible and visual evacuation alarms
- Activate warning beacons and or countdown indicators
- Shut down all air-conditioning systems serving the protected room
- Initiate the programmed discharge delay period
- Allow operation of the emergency abort station during the discharge delay period
- Automatically discharge the extinguishing agent upon completion of the programmed delay period
- Maintain alarm indication until authorised system reset
- Record alarm and event history where supported by the control panel

- Perform a Door Fan Test (Enclosure Integrity Test) following installation and prior to final commissioning
- Verify that the enclosure maintains the required extinguishing concentration hold time in accordance with the manufacturer requirements
- Demonstrate system operation to client representatives
- Verify alarm sequences and release sequences
- Verify countdown functionality
- Verify manual release operation
- Verify abort operation
- Test interfaces and shutdown functions
- Test fault monitoring functions
- Complete commissioning documentation
- Rectify all defects identified during testing

7. ACCEPTANCE CRITERIA

The installation shall only be accepted when:

- All design documentation has been submitted and approved
- The enclosure integrity test has been successfully completed
- Detection systems have been tested and verified
- All alarm functions operate correctly

14. DELIVERABLES

The successful contractor shall provide a fully operational automatic fire suppression system complete with all documentation, certification, testing, commissioning records, enclosure integrity testing records and professional sign-off required for regulatory compliance and client acceptance.

15. PROJECT SCHEDULE AND COMPLETION REQUIREMENTS

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
