APPOINTMENT OF A SERVICE PROVIDER FOR GRASS CUTTING ON UNDEVELOPED ROAD RESERVES, PUBLIC OPEN SPACES AND PARKS IN THE CITY OF TSHWANE (REGION 2)

1. BACKGROUND INFORMATION

The purpose of the Request for Quotations is to appoint a service provider for the cutting of grass, weeds, the eradication of declared weeds on all undeveloped road reserves, public open spaces and parks in the city of Tshwane (region 2)

The recent heavy rains experienced throughout the city have resulted in excessive/ overgrown grass and weeds across the region. To address this challenge, the office requires assistance from an external contractor to augment the current internal capacity. The Contractor will be responsible for the cutting of all types of grasses and weeds on all undeveloped road reserves, undeveloped traffic islands, undeveloped public open spaces, parks, "Spruit" areas and stormwater canals as and when required in the following wards: Wards 5, 8, 13, 14, 49, 50, 73, 74, 75, 76, 95, 96.

The Contractor will be expected to cut grass on surfaces as stipulated in this document to the satisfaction of the city. The individual working sites will be demarcated and explained during the various site meetings. The Contractor shall be informed by the Clerk of Works when to do the cutting and must start with the work within five (5) days after he had been notified by the Clerk of Works. The following equipment will be required to perform the tasks, amongst others:

- The contractor will be required to provide tractors equipped with a slasher: to cut the grass to a constant height of not more than 100mm.
- Mechanical brush cutter. To cut the grass to a constant height of 100mm. It may not be cut shorter than 75m.
- All areas where the grass abuts into kerbs, fences, poles, buildings etc. is to be neatly trimmed at a constant height of 100mm and not cut shorter than the rest of the area's minimum height prescribed.
- If an area is not cut according to the standard as set above, the bidder will be responsible for the re-cutting of the affected area immediately to the correct levels with the appropriate equipment at his/her own cost.
- The type of mower to be used on the site will be approved in consultation with the Clerk of Works
- Care must be taken that no trees, shrubs, fences, poles, walls, paving, traffic signs, private and public property etcetera are damaged during the cutting and/ or removal period on the site. Any damage to public or private property caused by the Contractor will be the responsibility of the Contractor and must be handled appropriately
- All loose objects (including paper, plastic bags, bottles, stones, wires, etc.) which can give rise to damage and further littering must be removed and placed into bags before the grass on the site is cut.
- Care must be taken that the cutting blades of all equipment that is utilized always needs to be sharp and safe to use according to manufacturer specification
- Cutting blades for the tractor mounted slasher-mowers must be of the prescribed type and standard for the specific type of mower; safety standards for the specific type of mower must be always adhered to. It must be suitable according to turf grass mowing industry standards to deliver the desired finish applicable for all grass types found on road reserves, public open spaces and "Spruit" Areas
- The Contractor is not allowed to refill or spill petrol, diesel or oil on any grass surface on a site. If any spillage or damage on a site occurs, the Contractor will repair the damage to the full satisfaction of the Clerk of Works
- Cutting must not be undertaken during exceptionally wet circumstances. The Clerk of Works is to be contacted at such an event to assess the situation to amend the cutting programme.

- Once grass cutting has commenced on a site or work portion, it shall be completed without delay and the contractor shall complete (including trimming and collection) one area of grass cutting before moving to the next work area
- The contractor shall allow in its rates for cutting around all obstacles and obstructions including tree bases, lamp columns, telephone columns, manhole covers, benches, swing bins, etc. within the work area to be cut. The same height standard of cut shall be maintained around obstacles and obstructions as required in the immediate adjacent areas by use of suitable machines or by hand cutting
- The contractor shall further allow in its rates for cutting rough, sloping or uneven ground including grass banks traverse, sides and bottoms of ditches which shall be cut to the same standard of finish as that specified on immediately adjacent level areas
- Care must be taken that the stems of trees are not damaged by mechanical brush cutters or any other equipment
- Tenderers must take note that the width of the road reserve will be the area from the road kerb up to the erf boundary. In the case of formal earth roads, the width of the road reserve will be the area from the shoulder up to the erf boundary. If the erf boundary is not clearly visible, an area of ten (10) meters from the road kerb or road shoulder will be the width of the road reserve.
- The work sites must always be kept free of declared weeds and declared invader plants and removal thereof must take place simultaneously with every cut on a site
- The Contractor will be responsible for the paying of any fees at the dumping site.
- All litter, foreign objects and grass clippings shall be collected into secured refuse bags that must be removed from the maintenance site simultaneously on the day of cutting. No separate payment shall be made for unearthed waste removal on the site.
- The CoT as an organ of state subscribes to the principles of Climate change mitigation and adaptation. As a result, the contractor/s shall be encouraged to use well-serviced and non-polluting devices like rakes and brooms. The CoT prefers that blowers and other power equipment are low-decibel, low fossil fuel consumption, and low emissions models.
- One-day extension will be granted each day on which 10mm or more of rain is recorded on site
- The contractor will be liable for any damage caused by stones/foreign objects to private property.

If the tenderer scoring the second-highest points does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring
