- 1.1. Bidders shall provide full and accurate answers to the questions posed in this RFP document, and, where required explicitly state “Comply/Non-Compliance” regarding compliance with the requirements. Bidders must substantiate their response to all questions, including full details on how their proposal/solution will address specific functional/ technical requirements; failure to substantiate may lead to the bidder being disqualified. All documents as indicated must be supplied as part of the bid response.
- 1.2. Failure to comply with Mandatory Requirements will lead to the bidder being disqualified.

2. INTRODUCTION

- 2.1. The Commission for Conciliation, Mediation and Arbitration (CCMA) is an independent statutory organisation that was established by the Labour Relations Act of 1995 (LRA) to deliver dispute prevention and resolution services to the people of South Africa. The core mandate of the CCMA is derived from the purpose of the LRA, which, amongst others, is to advance economic development, social justice, labour peace and the democratisation of the workplace.
- 2.2. The CCMA employs approximately eight hundred and sixty-six (866) Full-Time employees and utilises the services of approximately four hundred and sixty-seven (467) Part-Time Commissioners and approximately one hundred and one (101) Part-time Interpreters. The CCMA National Office is in Johannesburg. Eight (08) Provincial Offices deliver services to users in the nine (09) provinces of the CCMA.

3. PURPOSE

- 3.1. The purpose of this document is to request call proposals from accredited and competent service providers to provide background checks and verification services to the CCMA's national, provincial, and regional offices over a period of three (3) years. The appointed provider shall provide background checks and verification services and will be engaged on an “as and when required” basis.
- 3.2. Vacancies in the CCMA cover a diverse range of occupations, including Entry-Level, Skilled Professionals, Senior and Executive-Level vacancies. The Background Checks and Verification Services extend beyond the normal battery of background checks in that they include fingerprint criminal checks and verification of National and/or International qualifications.

4. TERMS OF REFERENCE

- 4.1. The Human Resources Management Unit is responsible for capacitating the organisation in order that the organisation is able to deliver on its mandate; by inter alia ensuring ensure that all individuals recruited into the CCMA, whether in the capacity of Employee, Independent Consultant or any other capacity meets the stringent organisational qualification and eligibility criteria
- 4.2. The CCMA seeks to appoint a provider who shall provide background checks and verification services for a period of three (3) years, anticipated start date 01 February 2026, ending on 31 January 2029.
- 4.3. The background checks and verification services will be utilised on an “as and when required basis” to the national, provincial and regional offices of the CCMA.

- 4.4. The background checks and verification services service provider must have capacity to deliver reports in a relatively short period
- 4.5. There is no guarantee that work will be allocated to the successful bidder during the term of the contract.

5. SCOPE OF WORK AND DELIVERABLES

- 5.1. At the request of the CCMA, the service provider will provide at least the following Services to the CCMA in relation to applicants:
 - 5.1.1. Conduct credit checks on applicants' credit history, including defaults, judgments, notices, disputes, and previous inquiries from various credit bureaus.
 - 5.1.2. Criminal Check using the AFIS fingerprint system, which will be done at the service provider's premises or such other place as agreed to with the CCMA and will include information relating to current charges and historic convictions.
 - 5.1.3. Verification of the National secondary qualifications of applicants.
 - 5.1.4. Verification of the Identity Document information of applicants.
 - 5.1.5. Verification of National and/or International qualifications of applicants.
 - 5.1.6. Conduct employment reference checks (two reference checks per applicant)
- 5.2. Provide the CCMA with the necessary software (online) tool to capture and release integrity checks of candidates for background screening purposes as and when required for the listed below:
 - 5.2.1. Previous, current and expunged criminal checks.
 - 5.2.2. Credit checks in relation to lifestyle; checks, direct supervisor
 - 5.2.3. Employment reference
 - 5.2.4. Directorship Check
 - 5.2.5. Court case search

The following formula will be used to calculate the points out of 80 for price in respect of tender with a rand value not exceeding R 50 million (inclusive of all applicable taxes). the lowest acceptable tender must score 80 points for price, and other tenders which are high in price must score fewer points, on pro rata basis.
