TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO CALIBRATE AND SERVICE (46) FORTY-SIX SCALES ON A QUARTERLY BASIS FOR A PERIOD OF TWO YEARS FOR THE SOUTH AFRICAN DIAMOND AND PRECIOUS METALS REGULATOR (SADPMR)

1. BACKGROUND

The South African Diamond and Precious Metals Regulator (SADPMR) is a state-owned entity which is based in Gauteng Industrial Development Zone (GIDZ) in Bonaero Park, Kempton Park. The SADPMR would like to enter into a two-years (2) contract with a reputable company that will be able to provide services to calibration of forty-six (46) scales to take place quarterly for a period of two years. The appointed service provider will be providing these services for the Diamond Exchange and Export Centre (DEEC) which is a division within the SADPMR. The Diamond Exchange and Export Centre facilitates the buying, selling, exporting and importing of diamonds in the Republic, as a result diamonds are handled on daily basis thus the scales are required for the frequent weighing of diamonds.

2. SCOPE OF SERVICE

Calibration of Scales

- Provide services for the calibration of forty-six (46) scales to take place quarterly for a period of two years.
- Provide proof in a form of certificates for each scale serviced per schedule.

3. PROJECT OUTPUT AND/OUTCOMES

- The SADPMR would like to enter into a two-year (2) contract with a reputable company that will be able to provide services for the calibration of forty-six (46) scales to take place quarterly for a period of two years.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
