1. BACKGROUND AND OVERVIEW OF THE PROJECT

1.1 INTRODUCTION

The Winnie Madikizela Mandela Local Municipality is entrusted with the responsibility to oversee the implementation of the Disaster Management Amendment Act, 2015 (Act 16 of 2015) and the National Disaster Management Framework, 2005 (Government Notice 654 of April 2005) throughout the District. Similarly, disaster risk management is a collaborative process involving all spheres of government, NGO's, the private sector, a wide range of capacity building partners and communities. It requires capabilities to continuously and on an on- going basis, to effectively anticipate, prepare for, respond to and monitor a range of natural and other hazards. The Winnie Madikizela Mandela Local Municipality is seeking to engage a contractor to maintain and clean 2 VIP Mobile toilets and Honey sucking of Mbizana Taxi Rank if and when necessary for the period of 36 months.

Toilets are potentially a risk for transmission of the virus if not managed well. The decision to maintain toilets and honey sucking of Mbizana Taxi Rank procure to reduce the risk of diseases that can caused by unmonitored health hazards.

The virus is believed to spread via a close contact with infected aerosol droplets, wherein the virus enters our body via breathing in these droplets or by touching a contaminated surface. Pursuing the procurement of the decontamination material, PPE and toilets is vital for the mitigating the risk of contracting the virus

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT FOR DESIGNATED SECTORS

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

1. General Conditions

- 1.2. Regulation 8.(2) prescribes that in the case of designated sectors, organs of state must advertise such tenders with the specific bidding condition that only locally produced or manufactured goods, with a stipulated minimum threshold for local production and content will be considered.
- 1.3. Where necessary, for tenders referred to in paragraph 1.2 above, a two-stage bidding process may be followed, where the first stage involves a minimum threshold for local production and content and the second stage price and targeted goals.
- 1.4. A person awarded a contract in relation to a designated sector, may not sub-contract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
