### **TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO RENDER SECURITY SERVICES AT THE SOUTH AFRICAN DIAMOND AND PRECIOUS METALS REGULATOR'S HEAD OFFICE IN O.R. TAMBO SPECIAL ECONOMIC ZONE FOR A PERIOD OF 24 MONTHS.**

---

#### **1. BACKGROUND**

The South African Diamond and Precious Metals Regulator (SADPMR) needs to appoint a Security Company to provide security services at its Head Office in Johannesburg. The appointed company should provide physical security for 24 hours, 7 days a week for a period of twenty-four (24) months.

#### **2. SCOPE OF SERVICE**

**2.1 The appointed service provider will be expected to provide a twenty-four-hour (24hrs) security service as follows:**

Day shift 06H00–18H00 and night shift 18H00–06H00

- 2 X Armed guards with handguns and all with minimum Grade C security Training during day shift
- 1X Unarmed Security Guards with minimum Grade C Training during day shift, must have competency certificate for exchange purposes
- 2 X Armed guards with handgun night shift

#### **2.2 Additional services and conditions**

- Provision of security service seven days a week including public holidays.
- Security Officers (including supervisor) must always be in uniform.
- Security Officers (including supervisor) must be physically and mentally fit for proper execution of their duties. No security guard should report for work under the influence of any intoxicating substance(s) [i.e. alcohol, etc].
- Security Officers (including supervisor) must be presentable at all times, dedicated and display professionalism in their conduct which shall imply inter-alia that there shall be no unnecessary arguments with visitors, staff or discourteous behaviour towards them.
- Declaration that the security officers (including supervisor) shall refrain from any action which might be detriment to the SADPMR or its employees.
- Security Officers and/or their supervisor are prohibited from reading and handling documents or records of the SADPMR, therefore no information concerning the SADPMR or third party must be furnished to the public or any media by the Security Company and/or its employees.
- Recording of all security related incidents in relevant Registers.
- Security Officers must be inspected once per day (weekends and public holidays included) by the Security Company or its representative, while records of such visits must be kept.
- The SADPMR will expected to provide a proof Criminal Records check/Police Clearance . Company shall provide PSIRA records to provide that the security officers are properly registered. The Security Company will be subjected to security screening.

- The Security Company shall take all possible steps to ensure that the execution of its duties is as intended in the agreement.

### **3. PROJECT OUTCOME**

- Employees and Assets of the SADPMR's Head Office are protected 24 hours, 7 days a week.

### **4. REPORTING REQUIREMENT**

- The Supervisor must call and report immediately any security breaches to the General Manager: Diamond Trade and provide written report thereafter. Monthly meeting will be held between Service provider and SADPMR Deputy Security Manager .

### **5. CONTRACT DURATION**

- The appointed Security Company shall provide security services for a period of twenty-four (24) months.

### **6. EVALUATION CRITERIA**

#### **6.1 Phase One Evaluation**

##### **6.1.1 Company Requirements**

**The following are compulsory requirements and if not attached on the proposal:**

- The Security Company must attach copy of certificate to prove that it is registered with the Private Security Industry Regulatory Authority (PSIRA). (absence of a valid registration certificate will result to immediate disqualification)
- The Security Company must attach copies of Firearm hand certificate/s as proof that they possess registered firearms. (absence of a valid firearm hand guns) certificate will result to immediate disqualification).
- The Company's security training plan.

##### **6.1.2 Company's Experience**

- The Company should have a minimum of four (4) years' experience in the protection of high value assets.

The Company should submit a minimum of three reference letters (on the letterhead of the company providing such reference) with verifiable contact details, where the bidder has provided guarding and transit operation.

##### **6.1.3 Infrastructure**

- An office that is equipped as per PSIRA requirement and be recognized by PSIRA as the registered office in terms of accreditation, that include at least a telephone line, e-mail address or fax number and is accessible 24 hrs. 7 days a week (proof of business address must be submitted). The company must provide the proof that it has office in Gauteng Province.
- Armoured vehicle for emergency and or in transit delivery, when need arise.

### **6.1.4 Supervisor's Experience and Qualifications**

- The Supervisor should have a minimum of five years 'experience within the security industry.
- The Supervisor should have a minimum Grade C certificate.
- Firearm hand guns competency certificate.

## **6.2 PHASE TWO EVALUATION**

### **6.2.1 Price Evaluation: Project Cost**

- Provide fixed price quotation for a twenty-four (24) months.
- Only one price adjustment per annum will be accommodated based on the statutory/or sector agreements increases as per PSIRA tariffs.
- Cost must be VAT inclusive and quoted in South African Rand.

### **6.2.2 Preference Evaluation: Historically Disadvantaged Individuals**

- Provision of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000 and its regulations 2011 will apply in terms of awarding points.
- Preference Points Claim Form, SBD 6.1 should be completed and signed by the bidder to be able to claim preference points.
- Calculation of points for B-BBEE status level contributor.
- Points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the table below:

- (i) **“QSE”** means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
