PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 To be completed by the organ of state:

The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable

tender will be used to determine the applicable preference point system; or

- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER

1. BACKGROUND

The South African Diamond and Precious Metals Regulator (SADPMR) is a Schedule 3A PFMA entity established in terms of section 3 of the Diamonds Act, 1986 (Act No.56 of 1986), as amended. The SADPMR derives its mandate from the Diamonds Act and the Precious Metals Act, 2005 (Act No. 37 of 2005). The SADPMR is in the process of procuring new furniture, and there is a need for the old furniture to be moved into a storage facility.

2. SCOPE

The SADPMR seeks to appoint a service provider to provide the storage facility for office assets while disposal/auction of old furniture is being undertaken. The furniture will be moved into the appointed service provider facility in three (3) phases.

2.1 Service to be Rendered.

The service to be rendered will include the following:

- Dismantling
- Removal
- Loading
- Transporting
- Offloading
- Handling packing
- Storage
- Re-assembly

2.2 Duration

- The contract will be for a fixed period of two months with the option of a month-to-month extension after the expiry of the first two months.
- During the period of the contract, the quantity of items stored will be decreasing.

2.3 Insurance

- The appointed service provider will be liable for loss and damages to the assets while in their care and storage.

3. TECHNICAL REQUIREMENTS

- Type of storage: warehouse storage
- Size of storage: 250 square meters
- Security facility: primary concern is safety and security

4. MANDATORY REQUIREMENTS

- The building/warehouse must be owned or leased by the bidder.
- The building/warehouse must be in a demarcated zoning area.
- If a service provider is in a joint venture, a signed joint venture agreement must be provided.
- The warehouse must be within a 40km radius from the SADPMR offices.

5. EVALUATION CRITERIA

- The evaluation criteria will have two phases: functionality as well as price and preference points.
- The briefing session will be conducted virtually on Teams.

5.1 Functionality

Bidders obtaining 60% or more on functionality shall proceed to phase two of the evaluation process

5.2 Preference Points System

The 80/20 principle will be applicable.

5.3 Specific Goals

A maximum of 20 points will be awarded to a bidder for the specific goals listed on the SADPMR preferential procurement policy as follows:
