1. INTRODUCTION

The SADPMR Board will embark on the Strategic Planning session scheduled on the 29th to the 30th of August 2022 as delegated governing body according to the principles of King IV and the prescripts of the PFMA. The Board requires sufficient time to align the Strategic Plan of 2020/2025 and the Annual Performance Plan of 2023/2024 accordingly.

The Board strategic plan will be attended by twenty-three (23) people comprising of Board members and Executive Management.

Services that are required for the session are: Conference Venue, Accommodation, Strategic Planning and Strategic intervention Facilitators.

2. SCOPE OF WORK

- Discussion of the Strategic intervention Session with Management and Board prior to the actual event
- Interactive and flexible facilitation tools and material aids prepared prior to the workshop.
