SCOPE OF WORK /SPECIFICATIONS OF GOODS REQUIRED/ TERMS OF REFERENCE

1. Background

Nsezi WTP is the water purification plant situated in the Richards Bay Region of uMngeni-uThukela Water Board. The plant uses various chemicals in water purification processes, which includes; Sodium Hypochlorite, Cationic Polymer (ULTRAFLOC 3800, U3800), etc.

Sodium Hypochlorite is stored in 3off $\pm 18m^3$ polyethylene tanks, and Cationic Polymer stored in 2off $\pm 20m^3$ tanks. These tanks have deteriorated, with high/increased maintenance costs, in terms of spares procurement and chemical leakage.

The above mentioned has informed the decision to replace 2 off existing chemical storage tanks with GRP tanks of similar size.

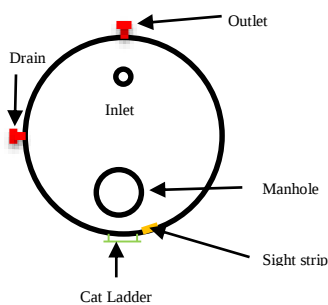


Figure 1: Sodium Hypo Storage Tank

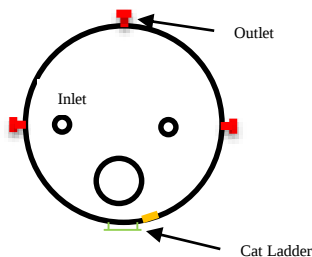


Figure 2: Cationic Polymer Storage Tank

2. DEFINITIONS
