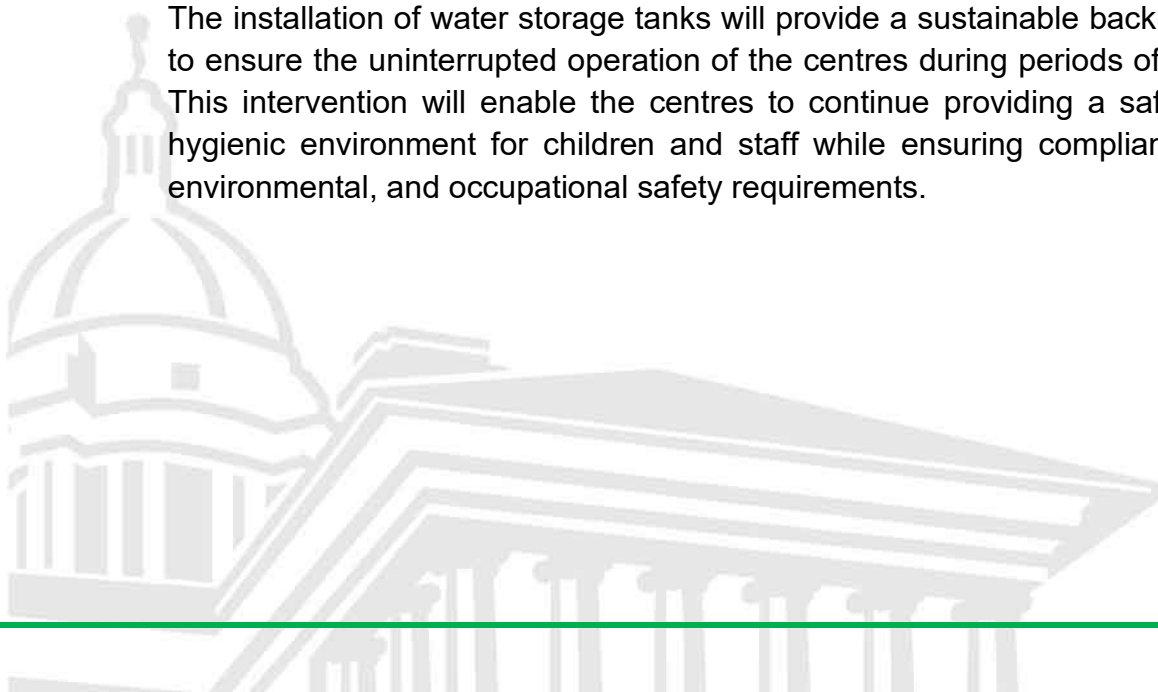

1. INTRODUCTION AND PURPOSE

The purpose of this procurement is to appoint a service provider for the supply, delivery, and installation of 10 000-litre water storage tanks at Council-managed Early Childhood Development (ECD) Centres in Regions 3 and 6.

The need for this procurement arises from recurring water supply interruptions experienced across various communities within the City of Tshwane. These disruptions have negatively affected the daily operations of ECD centres by limiting access to clean and reliable water required for essential services.

The installation of water storage tanks will provide a sustainable backup water supply to ensure the uninterrupted operation of the centres during periods of water outages. This intervention will enable the centres to continue providing a safe, healthy, and hygienic environment for children and staff while ensuring compliance with health, environmental, and occupational safety requirements.



2. BACKGROUND

Early Childhood Development (ECD) Centres provide care, protection, nutrition, and early learning services to vulnerable children between the ages of 3 and 5 years. Continuous access to clean and safe water is essential for the daily operation of these facilities.

Due to recurring water interruptions, ageing municipal infrastructure, and emergency supply disruptions, many centres are unable to maintain a consistent supply of water. This directly affects health and hygiene standards, food preparation, sanitation, and overall service delivery, while also placing the centres at risk of non-compliance with environmental health and occupational health and safety regulations.

The procurement and installation of 10 000-litre water tanks is therefore a critical intervention to improve service continuity, strengthen resilience against water supply disruptions, and ensure compliance with applicable legislation and municipal standards.

The stored water will support essential daily activities, including:

- Drinking water for children and staff;
- Food preparation and kitchen operations;
- Handwashing and personal hygiene;
- Cleaning and sanitising classrooms, kitchens, and ablution facilities;
- Flushing toilets and maintaining sanitation standards; and
- General cleaning and maintenance of the facilities.

3. PROJECT SCOPE

The scope of this project includes the supply, delivery, installation, testing, and commissioning of 10 000-litre water storage tanks at Council-managed Early Childhood Development (ECD) Centres located in regions 3 and 6.

The appointed service provider will be responsible for all labour, materials, equipment, fittings, and accessories necessary to ensure that the water storage systems are fully operational and compliant with relevant engineering, health, safety, and municipal standards.

The scope of work includes, but is not limited to, the following:

- Supply and delivery of 10 000-litre water storage tanks;
- **Construction of heavy-duty, high-grade steel, precise levelling and strong concrete foundation suitable to carry the tank with capacity of 10 000L. The desired height of the stand must be 1,5m.**
- Installation of all associated pipework, valves, fittings, overflow systems, and connections;
- Connection of the tanks to the existing water supply infrastructure;
- Installation of booster pumps where required to ensure adequate water pressure;

- Testing, commissioning, and inspection of the complete installation;
- Rectification of any defects identified during commissioning;
- Provision of operation and maintenance manuals

The scope of this project is for the supply, delivery, and installation of 10 000 litre water tanks for Council-managed Early Childhood Development (ECD) Centers.

4. DELIVERABLES

- Supply of new, high-quality 10 000-litre water storage tanks that comply with the approved technical specifications.
- Delivery of all water tanks, booster pumps (where applicable), and associated materials to the designated Council-managed ECD centres.
- **Construction of heavy-duty, high-grade steel, precise levelling and strong concrete foundation suitable to carry the tank with capacity of 10 000L. The desired height of the stand must be 1,5m.**
- Complete installation of the water tanks, including all necessary pipework, valves, fittings, overflow systems, and connections.
- Installation and testing of booster pumps where required to ensure adequate water pressure.
- Testing and inspection of the complete water storage system to confirm that it is fully operational, leak-free, and functioning according to the required specifications.
- Handover of fully functional water tank systems to authorised City of Tshwane officials.

5. VALIDITY PERIOD

The validity period for the tender after closure is 90 days.

6. CONDITION

- The proposed water tanks must comply with the national standard for polyethylene water storage tanks, **SANS 1731:2017** and be suitable for potable (drinking) water storage.
- The bidder must provide manufacturer's warranty of 10 years from the date of purchase for standard molded water tanks and any associated equipment, including booster pumps where applicable.
- The certificate of conformance (CoC) will be provided by the service provider upon completion of the project.
- The bidder must have qualified plumbers to undertake plumbing, and installation works in accordance with the National Building Regulations, local municipality By-laws and the South African National Standards (SANS 10252-P).

7. COMPULSORY BRIEFING SESSION

Site visits will be conducted to all ECD centres on the date of the briefing and service providers are expected to cater themselves for transportation.
The starting point will be as per advert.

8. STAGES OF EVALUATION

The Quotation will be evaluated in 3 phases:

Stage 1: Administrative Compliance
Stage 2: Mandatory Requirements
Stage 3: Preference Point System

8.2 MANDATORY REQUIREMENTS

Prospective bidders must submit the following mandatory requirements with their tender submission:

The bidder must provide 2 or more signed contactable reference letters for sites where installation was done. It must be on the client's letterhead.

8.3 PREFERENCE POINT SYSTEM

The preferential point system used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- 80 points for price
- 20 points for Specific goals

SPECIFIC GOALS

- Bidders are required to submit supporting documents for their bids to claim the specific goal points.
- Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.

- Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

11. TYPE OF AGREEMENT REQUIRED

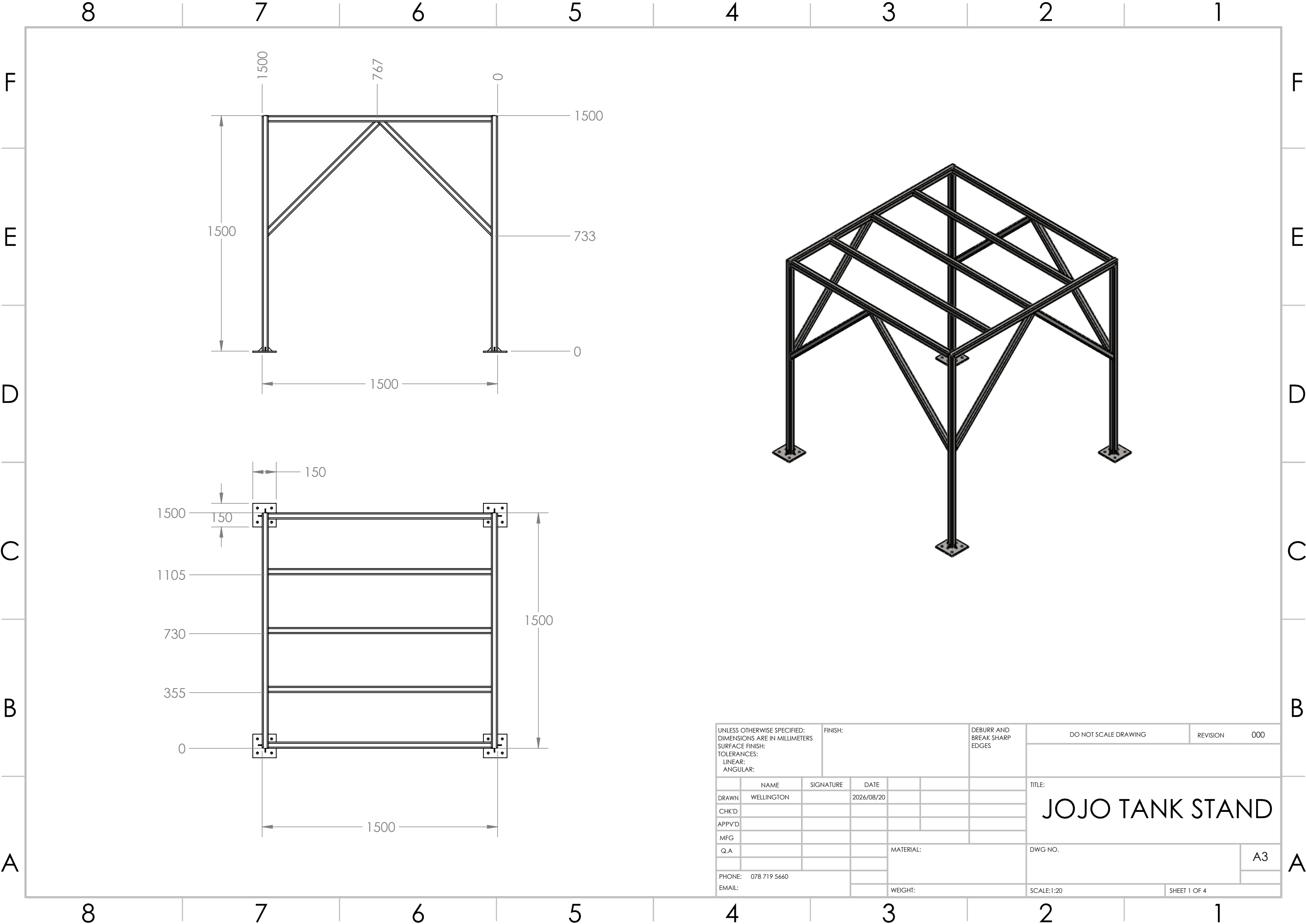
The Service Level Agreement to be required by the successful bidders to be signed when appointments are finalized.

12. MARKET ANALYSIS

The city of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the tenderer if they will be able to deliver on the price, if a tenderer confirm that they cannot, the tenderer will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.

- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
