The Inkosi Langalibalele Municipality subscribes to the Preferential Procurement Regulations, pertaining to the preferential procurement policy framework act (PPPFA) principles whereby a tenderer's submission will be evaluated

according to the sum of the award of points in respect of the tender value and the B-BBEE status of the tenderer. The tender will be evaluated on 80/20 as per the PPPFA Regulations and shall be based on pre-qualification and functionality. Bidders are required to submit a fully completed tender document issued by the Inkosi Langalibalele Local Municipality accompanied by a company's CSD (Central Supplier Database) Report, CIPC Documents, Certified Identity Documents of all Directors, Letter of Good Standing from the Department of Labour, Valid copy of the Tax Clearance PIN from the Receiver of Revenue, Rates and Taxes Statement obtainable from the Local Municipality, alternatively, Valid Lease Agreement. Please note that the onus is upon the tenderer to ensure that the Tax matters are **always** up to date.

**Service providers operating in exempted areas shall submit an exemption letter obtainable from a Local Municipality.**
