

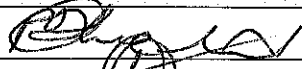

1. PURPOSE

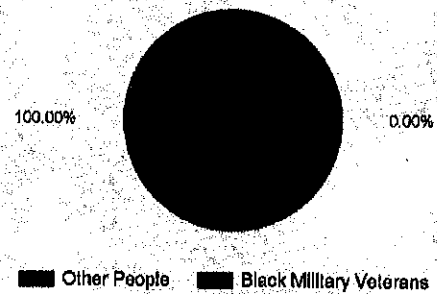

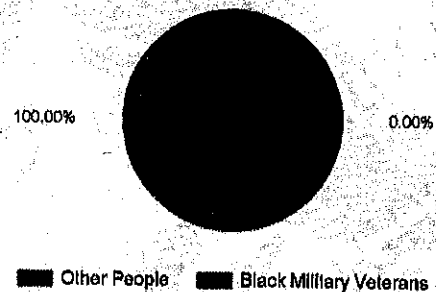

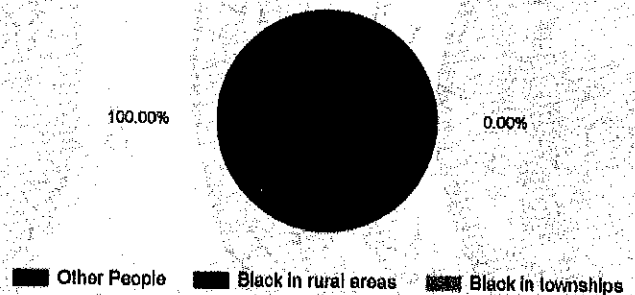
