In responding to this bid, PRASA acknowledges that it may obtain and have access to personal data of the Respondents. 1 SCOPE OF WORK

PRASA has a requirement of 250 point of sale devices and a successful bidder will need to do the following:

- Deliver the required number of portable devices as indicated above.
- Ensure that the devices are registered and can process cashless payments on the republic of South Africa
- Provide maintenance for the devices for a minimum of 24 months.
 - Maintenance:
 - Fixing or replacing malfunctioning devices.
 - Ensure devices have up-to-date firmware.

- Ensure that the operating system for POS system is up to date including patches and new features.
- Ensure that each device has a charger, and provide pouches for the number of devices requested.
- Register and sign off the software version(s) which works with ticketing system (ITIX) developed and shared by the ITIX service provider to enable it to connect with the devices. The signed software is to be distributed and managed via the intelligent terminal management platform.
- The potential bidder must provide one sample of the proposed device to be tested for compatibility before the final award is confirmed, and should the device not be suitable then an appropriate device must be provided before final approval. The devices must meet the specifications and be approved by South African banks.
