Tenders shall be valid for a period of 90 days after the closing date of the submission of tenders. **Under no circumstances will late tenders be accepted.**

Service Providers are requested to attach these required documents in their tenders on the pages indicated in the Tender document:

- Certified ID copies for the entity owner/s (Not older than 3 months from the date of tender closure)

- A copy of the tenderer's professional indemnity insurance.
- copy of the tenderer's professional registration certificates of all personnel with the Engineering Council of South Africa (ECSA) in line with the Engineering Professions Act 46 of 2000.
- Certificate of Quality Systems in line with ISO9001 or similar system certificate
- Proof of municipal rates clearance or a signed lease agreement by both parties or confirmation that there is no billing where the entity is based
