1. INTRODUCTION

1.1 INTRODUCTION TO THE MINE HEALTH AND SAFETY COUNCIL

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve OHS conditions in South African Mining Industry.

2. PART A: THE CONTRACT

2.1 CONTEXT OF THIS PROCUREMENT

The MHSC requires service provider to replace sensor taps in the bathrooms at MHSC offices.

2.2 CONTRACT PERIOD

The contract will be valid for a period of once off.

2.3 TERMS OF REFERENCE

MHSC seeks to appoint a service provider to render once off plumbing work expertise by replacing existing sensor taps, supplying and installing new sensor taps in the bathrooms at 145 Western Service Road, Woodmead.

2.3.1 DETAILED SPECIFICATIONS/SCOPE OF WORK

The service provider is expected to:

- To remove the existing tile in order to access the sensor tap.
- To remove existing damage three sensor taps, supply and install the new three sensor taps.
- To remove working one sensor taps and reinstall one sensor tap in another bathroom to match the existing sensor tap.
- To supply and install new tile that were removed during the repair to match existing tiles.
- Repair urinal that leaks when pressing the push button.





NB: The service provider will be fully responsible for meeting all requirements in this document regarding the work. The service provider must ensure that all work, material and equipment used on this maintenance work complies with SANS 1475, Occupational Health and Safety Act (OHS Act No 85 of 1993) and National Building Regulations and Building Standards 103 of 1977 (SANS 10400).

GENERAL INFORMATION.

The material item price shall be based on standard market related plus the percentage mark-up fee.

GUARANTEE.

All new equipment, materials, workmanship, repaired are furnished with a written guarantee which includes a defects liability period from date of completion.

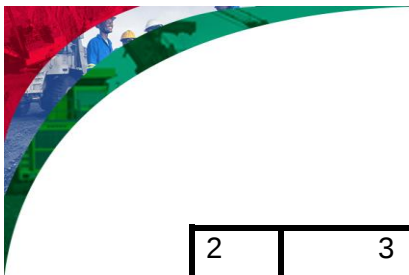

4. PART C: RFQ SELECTION PROCESS

4.1 RFQ CLOSING

- 4.1.1 There shall be no discussions with any enterprise until evaluation of the proposal has been complete.

- 4.1.2 Any subsequent discussions shall be at the discretion of MHSC. Unless specifically provided for in the proposal document, RFQ's submitted by means of telegram, telex, facsimile or similar means shall not be considered by MHSC.
- 4.1.3 All RFQ's shall close on the specified date and time as stipulated in the RFQ document.
- 4.1.4 RFQ's received after closing time and date will be classified as LATE and will not be considered.
- 4.1.5 RFQ's submitted in any other manner other than the specified address (designated email address) shall not be accepted.

4.2 ADMINISTRATIVE COMPLIANCE (RETURNABLE DOCUMENTS)

Administrative compliance/responsiveness will be tested based on returnable documents submitted and signatures on the RFQ documents.

At this stage the verification is to review bid responses for purposes of assessing compliance and governance with RFQ requirements, whereby a bidder **will** be disqualified if they do not fully comply, it must be determined what documents are required to be returned by Bidders.

RFQ responses will be verified for compliance with the procedural requirements of the RFQ, which entails the completion and/or submission of the returnable documents and schedules specified in the Returnable Documents and Schedules Checklist below. **No award will be done without complete provision of returnable documents and any schedules.**

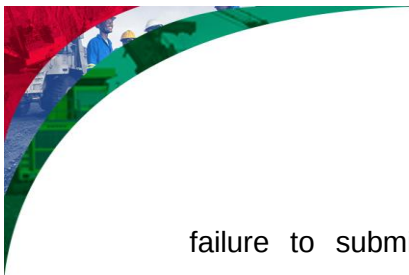

The SBD 7 contract form will be required, where applicable, from the recommended bidder upon award.

4.3 MANDATORY COMPLIANCE – CENTRAL SUPPLIER DATABASE

Bidders are required to be registered on the Central Supplier Database (CSD) of National Treasury prior to submitting their bid (open tenders). Failure to being registered on the CSD and



failure to submit the requested proof of registration on CSD information will lead to disqualification. (Please provide proof of registration on the Central Supplier Database).

Only suppliers who are registered with the Central Supplier Database **(CSD)** will be considered for this bid. Bidders who are not registered on CSD, will be disqualified.

4.4 MANDATORY COMPLIANCE – TAX STATUS VERIFICATION

Bidders are required to submit their tax compliance status with their bid in the form of a Tax Verification PIN from SARS or CSD supplier number which must be captured in the SBD 1. MHSC only conducts business with bidders whose tax matters are in order. Failure to comply in terms of tax obligations will render your bid non-responsive and disqualified. It is the responsibility of the bidder to ensure they are tax compliant at time of submitting their response.

4.5 PROTECTION OF PERSONAL INFORMATION ACT, 4 of 2013 (POPIA)

MHSC adheres to the Protection of Personal Information Act, 4 of 2013 (POPIA) requirements regarding personal information which came into effect 1 July 2021. As MHSC, we are committed to protecting your privacy and ensuring that personal information collected is used properly, lawfully, and transparently.

4.6 OCCUPATIONAL HEALTH AND SAFETY

The service provider acknowledges that he is fully aware of the provisions of the Mine Health and Safety Act 29 of 1996.

MHSC promotes a culture of occupational health and safety in the mining industry.

The service provider acknowledges that he is fully aware of the provisions of the OHS Act 85 of 1993 and that he is an employer in his own right with duties and responsibilities as prescribed in the Act.

5. PART D: RFQ EVALUATION PROCESS

The evaluation process will be conducted in various stages. To move to the next stage of evaluation, the previous stage of evaluation must have been fully complied with.

5.1 MANDATORY TECHNICAL EVALUATION – STAGE 1

- Verify that mandatory requirements are met as per the bid document.
- The bidder must indicate its compliance / non-compliance to the requirements and should substantiate its response/s with supporting evidence. If more space is required to justify compliance, please ensure that the substantiation is clearly cross-referenced to the relevant requirement.
- Failure to comply with Mandatory Requirements will lead to the bidder being disqualified, and not considered for further evaluation.

5.2 TECHNICAL/FUNCTIONALITY EVALUATION – STAGE 2

- Evaluate the bid responses in line with the evaluation criteria detailed under paragraph “*Technical / Functionality evaluation*”. Bidders must achieve **[60%]** in this phase for their bid to progress to the next phase of evaluation.

5.3 PRICE AND PREFERENCE (SPECIFIC GOALS) EVALUATION – STAGE 3

- Bid price proposals are compared on an equal and fair basis, considering all aspects of the bid pricing requirements. Qualifying bids are ranked on price and specific goals points claimed in the following manner:
 - Price** - with the lowest priced bid receiving the highest price score as set out in the Preferential Procurement Regulations 2022.
 - Preference** - preference points are allocated in accordance with the Preferential Procurement Policy Framework Act (Act 5 of 2000) and its Regulations 2022 as claimed in the specific goals claim form (SBD 6.1) are added to the price ranking scores. The points for specific goals must be supported by a valid B-BBEE certificate or certified sworn affidavit.

A maximum of 80 points will be allocated for price on the following basis:

A maximum of 20 points will be allocated for specific goals on the following basis:

- The tenderer must indicate how they claim points for each preference point system in line with the specific goals of the RFQ as outlined in SBD 6.1.

5.4 IMPORTANT NOTICE TO BIDDERS

Bidders are to be aware of scammers who pose as MHSC employees selling bid documents or offering monetary gratuity in exchange for information or awarding of bids.

MHSC is in no way selling the bid document, all documents shall be found on the MHSC website and National Treasury eTender Portal and awarded bids are notified through the website and MHSC shall never ask any bidder for monetary gratuity in exchange for information or manipulating outcome of bids.

5.5 CORRESPONDENCES AND QUERIES

Should it be necessary for a bidder to obtain clarity on any matter arising from or referred to in this RFB document, please refer queries, in writing, to the contact person(s) listed above in SBD 1 or below. Under no circumstances may any other employee within MHSC be approached for any information.

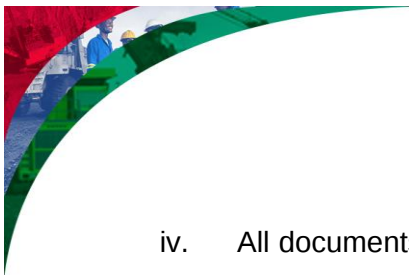

5.6 STANDARD CONDITIONS OF THE RFQ

- i. MHSC may conduct the reference checks based on the references provided.
- ii. The MHSC may where applicable request samples from the bidder/s to confirm capability.
- iii. The MHSC reserves the right to terminate the contract during the first week after work has commenced should the appointed service provider have misrepresented themselves and/or their product and will not be able to fulfil the requirements as contained in the contract, which might result in the MHSC failing to deliver on its mandate timeously.

- iv. All documents and certifications required in terms of the bid requirements must be valid at time of submission of the bid on the closing date and time.
 - v. No part of the contents of this document may be used, copied, disclosed, or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this bid, without prior written permission from the MHSC.
 - vi. Late submissions will not be accepted.
 - vii. A submission submitted in response to this RFQ will constitute a binding offer which will remain binding and irrevocable for a period of thirty (30) days from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the bid validity period is still in force. Pricing schedules must be completed in full. Should the total bid prices differ, or calculation errors be identified, the one indicated on the price schedule shall be considered the correct price.
 - viii. Any bidder who has reasons to believe that the RFQ specification is based on a specific brand must inform the MHSC before bid closing date.
 - ix. No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued.
 - x. All questions regarding this RFQ must be forwarded to the designated email address within at least 24 hours after the bid has been issued.
 - xi. It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the bid.
 - xii. The MHSC shall evaluate each responsive submission in terms of the method of evaluation stated in the bid document.
 - xiii. If the MHSC amends this RFQ, the amendment will be communicated to the bidders using the same platforms which the RFQ was advertised. No oral amendments by any person will be considered or acknowledged.
 - xiv. The MHSC reserves the right to carry out site inspections or call for supporting documentation to confirm any information provided by a Bidder in its RFQ.
 - xv. Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.

5.7 PRICE NEGOTIATIONS

The award of this RFQ may be subject to price negotiations with the preferred bidder or bidders, where there are opportunities where prices are not market related.

5.8 CANCELLATION OF RFQ

MHSC reserves the right to cancel this RFQ due to the following reasons:

- a) Due to changed circumstances, there is no longer a need for the services specified in this RFQ.
- b) Funds are no longer available to cover the total envisaged expenditure for the project.
- c) No RFQ meets the required specifications.
- d) There is a material irregularity in the RFQ process.

5.9 FINANCIAL PAYMENT

Payment will be made in accordance with section 38(1)(f) and 76(4)(b) of the PFMA and Treasury Regulations 15.10.1 and 8.2.3 (within 30 days from receipt of invoice after completion of deliverables).

5.10 DUE DILIGENCE

Where circumstances justify it, MHSC reserves the right to conduct due diligence (interviews, samples, presentations, site visits) with bidders who meet the minimum qualifying requirements on the evaluation phases, whereby bidders will present further information or provide further proof to the evaluation team. In these cases, MHSC may provide the areas of concern to the short-listed bidders to address in their presentations. MHSC reserves the right to not award to any bidder who does not meet the requirements of the MHSC.



5.11 RFQ AWARD

Awarding of RFQ's will not be published on the National Treasury e-tender portal or MHSC' website. No regret letters will be sent out. An RFQ is considered awarded when an official purchase order as signed by the delegated authority of the MSC is issued to the service provider. Goods may be delivered, or services may be rendered only with an official purchase order as signed and issued by the MHSC.

5.12 REASONS FOR DISQUALIFICATION

MHSC reserves the right to disqualify any bidders who do not comply with one or more of the following RFQ requirements and may take place without prior notice to the bidder:

- Bidder whose tax matters are not in order (Instruction Note 09 of 2017/2018 Tax Compliance Status will apply).
- Bidders who are not registered with the Central Supplier Database (CSD).
- submitted incomplete information and documentation according to the requirements of this RFQ document.
- submitted information that is fraudulent, factually untrue or inaccurate information.
- received information not available to other potential bidders through fraudulent means.
- failed to comply with mandatory and technical requirements as stipulated in the RFQ document.
- misrepresented or altered material information in whatever way or manner.
- promised, offered, or made gifts, benefits to any The Mine Health and Safety Council (MHSC) employee.
- canvassed, lobbied to gain unfair advantage.
- committed fraudulent acts; and
- acted dishonestly and/or in bad faith etc.

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

The Mine Health and Safety Council (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). The Mine Health and Safety Council (MHSC) appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC. 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty. 15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser. 15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights, which the purchaser may have against the supplier under the contract.

	17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

GCC18	18. Contract amendment
	18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
GCC19	19. Assignment
	19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
GCC20	20. Subcontract
	20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract
GCC21	21. Delays in supplier's performance
	21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract. 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract. 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority. 21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

	21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties. 21.6. 	23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part: 23.1.1. If the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2; 23.1.2. If the Supplier fails to perform any other obligation(s) under the contract; or 23.1.3. If the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the

	supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated. 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. 23.4.
