IThemba LABS is looking for a service provider to perform Validation/Qualification of the Systec VX-75 Autoclave for a period of three years.

Required service:

Validation runs that cover Bowie Dick Test runs, empty and loaded chamber heat distribution studies and heat penetration studies.

- 3 empty chamber heat distribution runs consisting of a minimum of 3 temperature loggers and 1 pressure logger for each run
- 3 loaded chamber heat distribution and heat penetration runs consisting of a minimum of 3 temperature loggers and 1 pressure logger for each run. (Loaded runs will include Biological indicators which will be provided by IThemba LABS)
- 3 bowie-dick card test runs for vacuum check (Supplier to provide bowie dick test card and a COA of the test pack)
- Lethality (F_0) value to be determined for loggers
- Timer verification
- Autoclave temperature probe verification

The temperature loggers/sensors should be pre-calibrated and cover a range of 50 – 140 °C and record every 5-10 seconds

The pressure logger/sensor should be pre-calibrated and cover a 0 – 250 kPa range

All data from the data loggers to be printed out and attached to the report.

A diagram or photograph of the sensor placement to be provided.

Note:

- An internal protocol will be provided to the appointed service provider
- Compulsory Radiation safety induction will have to be completed by the appointed service provider before coming on site.

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
