1. BACKGROUND

The project was identified in relation to the city's obligation to make provision in the departmental budget to procure absorbents utilised for oil spillages. The absorbents will be utilized at all fire stations throughout the City of Tshwane. The communities of the City of Tshwane will benefit directly and indirectly from this project since these absorbents will be used to address oil spills and other related spills caused by accidents.

2. PROJECT SCOPE

It is the intent of the City of Tshwane that these specifications cover the supply, delivery and offloading of absorbents on an as and when required basis for a period of twelve (12) months.

With a view to obtaining the best results and the most acceptable product for service in the Emergency Services Department, these specifications cover only the general requirements. Minor details of materials where not otherwise specified are left to the discretion of the bidder.

All products and accessories shall be new and of the highest quality. They shall be protected from damage; any damaged, flawed or defaced materials shall be rejected and replaced at a cost by the service provider.

The bidder shall further warrant that all materials / goods supplied under tender award shall have no defect, arising from design, materials, or workmanship or from any act or omission of the supplier that may develop under normal use of the supplied goods in the conditions

prevailing in the country of destination.

Tenderers are required to provide laborers and equipment for the off-loading of the ordered items.

The full scope, which includes the supply, and delivery of absorbents will be awarded to one bidder.

The supplier must be able to deliver the product during an emergency or as and when required anywhere within the CoT jurisdictional area.

If the bidder does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the City reserves the right to cancel the quotation.
