South African National Parks invites tenders for the **Construction of a Swimming Pool at Die Stroom Picnic Site in Bontebok National Park in the Western Cape Province**

ELIGIBILITY

1) CIDB Grading

The following tenderers who are registered with the CIDB, or are capable of being so registered prior to the evaluation of submissions are eligible to submit tenders:

- Contractors who have a CIDB contractor grading designation of **4GB** or higher, and
- Joint ventures are eligible to submit tenders provided that:
 - (i) Every member of the joint venture is registered with the CIDB;
 - (ii) The lead partner has a contractor grading designation in the **4GB** or higher class of general building construction work, or not lower than one level below the required grading designation in the class of construction works under consideration and possess the required recognition status and
 - (iii) The combined contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a **4GB** class of general building construction work or a value determined in accordance with Regulation 25 (1B) of 25(7A) of the Construction Industry Development Regulations

2) Functionality Criteria:

As part of the eligibility criteria, tenderers shall further be required to satisfy the following functionality criteria and be required to demonstrate their ability to undertake the work and to provide proof of experience IN General Building Maintenance projects. (GB), specifically new building works.

Tenderers are required to score a minimum of **8 points** out of a possible **12 points** (i.e. 70%) in order to be responsive: Tender Data, of the proposed functionality criteria and point system for evaluation.

Tenderers who fail to meet the minimum threshold shall be declared non-responsive and subsequently rejected. The onus rests with the tenderer to supply sufficient information to allow for the proper scoring, evaluation and award of points.

The following functionality criteria apply:

- (a) **General Building Construction Experience (Maximum 12 points)**

Where insufficient information is provided, zero points will be awarded for such particular criterion. The quality criteria and maximum score in respect of each of the criteria as follows:

Contracts of value between R 1 00 000 and R 4 500 000 million, inclusive of VAT	1 point per contract	4
Contracts of value exceeding R 4 500 000 million Inclusive of VAT	2 points per contract	8

The tenderer must submit a list of past and current projects for functionality evaluation – information must clearly state project information.

Tenderer to submit the following to proof experience:

- **New projects - Letter of appointment for current projects, stating scope of work, contract value and address where project is/will be done and,**
- **Completed projects - Letter of appointment and Completion certificates” for completed projects.** The appointment letter must include the scope of work and value of the project.

SPECIFIC GOALS

Preferential Procurement Regulations, 2022.

SANParks has identified the following specific goals to advance the categories of persons as part of its procurement processes.

Specific goals for the tender and points claimed are indicated per the table below:

To qualify, the bidder must have a working footprint in the Western Cape Province and provide Verifiable proof of business address in the Western Cape Province, older than two years.	10

The following will be accepted as proof:

1) Black ownership

- Bidders to submit valid B-BBEE certificate or sworn affidavit clearly indicating the percentage Black ownership.

2) Exempted Micro or Qualifying Small Enterprises

- Bidders to submit valid B-BBEE certificate or sworn affidavit clearly indicating the type of enterprise.

3) Locality

To qualify, bidder must provide / include verifiable proof of business address in one of the criteria, older than 2 years:

- Rental/Lease agreement in the name of the bidding company to include rental/lease period (start & end date) with proof of payment for the month prior to closing of the tender, or.
- Ownership of business premises – municipal/Eskom services account in the name of the bidding company to confirm 2-year business address.

NB: Bidders who are not located in the Western Cape Province and who are not EME's or QSE's may still tender but will not claim points for specific goals. Failure to provide the afore-mentioned documentation, will result in an allocation of zero points for specific goals.

A **compulsory clarification meeting** with representatives of the Employer will take place at:

Prospective tenderers who arrive later than 11:15 will not be allowed into the Clarification meeting.

The Tenderers shall inspect and examine the Site and its surroundings and shall satisfy themselves before submitting their tender as to the form and nature of the Site, the quantities and nature of the work and materials necessary for the completion of the Works and the means of access of the Site, the accommodation they may require and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their tender. **The tenderers must be represented at the site inspection by a person who is suitably qualified and experienced to comprehend the implications of the work involved.**

Attendance of the site inspection is compulsory, and a tender will be disqualified if the site inspection is not attended by a representative of the tenderer.

Requirements for sealing, addressing, delivery, opening and assessment of tenders are stated in the Tender Data.

The closing date and time for receipt of tenders is on 13 May 2025 at 11:00.
