TERMS AND CONDITIONS OF REQUEST FOR QUOTATION (RFQ)

1. No services must be rendered or goods delivered before an official Broadband Infraco Purchase Order form has been received.
2. Late and incomplete submissions will not be accepted.
3. Any bidder who has reasons to believe that the RFQ specification is based on a specific brand must inform Broadband Infraco before RFQ closing date.
4. Where applicable, Work will be carried out in terms of the OHSA and regulations and therefore it is important for the bidders to include OHSA compliance costs (i.e safety file for the recommended bidder will be approved by Broadband Infraco).
5. **Bidder is required to submit copy of Tax Clearance Certificate and verification information (PIN) to be used by Broadband Infraco to validate the copy on the SARS website for all price quotations exceeding the value of R30 000 (VAT included). Failure to submit the copy of valid Tax Clearance Certificate and verification information will result in the invalidation of this RFQ. It is the responsibility of the bidder to ensure that Broadband Infraco is in possession of the bidder's valid Tax Clearance certificate.**
The onus is on the bidder to ensure that Broadband Infraco receives a valid Tax Certificate as soon as the validity of the said certificate expires.

The bidder must indicate **clearly** which portion of the quoted price is linked to the exchange rate. The cost of installation, delivery, and **other** charges must be included in the total price quoted.
10. It is within Broadband Infraco's prerogative to award this bid in part/s or whole to one or more than one service provider based on the pricing and other technical consideration within the ambits of the law.

 - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution.

1. BACKGROUND

Broadband Infracore received a request for quotation in October 2019 for a 10Gbps Ethernet service at an SLA of 98,0%, from Rondebosch Teraco Data Centre to TENET NMU George Campus, to serve as a new redundancy route for the NMU Campus. The award was confirmed on 16th March 2020 and followed by a Service Order Form on 17th March 2020. The Service was initially required by the customer on 26th November 2020 but the completion date had to be revised to the 31st of March 2021. This date was however not met due to internal process and wayleave approvals that got delayed.

Due to the urgent need to connect the Campus, a speedy solution was implemented to drop the cable on the ground for the 4KM provincial section that is pending wayleave approval, and the client was connected on the 16th of April 2021.

Wayleave approval was granted with a condition of moving the entire solution from the left to the right-hand side of the road. This condition called for, Bush Clearing, moving the manhole from the left to the right-hand side, concrete encasement on the mountain, bridge attachments and a EIA report.

The imposed conditions from the Wayleave required variation orders for 3 line items, to seek much reasonable pricing for the new solution. The solution was implemented, however during implementation a force majeure occurred where about 150m of the portion of the road sunk and forced a temporary solution of aerial fibre. The service was successfully handed over in December 2021. Tenet now announced that the road works have been concluded and the road has been successfully restored, however the fibre is exposed and poses a concern of service interruptions and as a result the signal strength has been weak.

This PR is to cater for the migration of the exposed fibre on the section where the temporary solution was implemented.

- Supply and install 242m x 110mm Corrugated Sleeve
- Supply and install 24m x 300mm and 2 x Dome Joints
- Supply and install 250m of duct
